<u>Coronavirus (COVID-19) Update - Actions Taken Concerning County Facilities and Commissioner's Office Staffing -March 17, 2020</u>

To: Union County Office Holders and Department Heads

From: Union County Commissioners

The Union County Commissioners appreciate all that our citizens and county employees are doing to help slow the spread of the coronavirus (COVID-19). We know this is a worrisome time, but if we all work together, we will come through this.

The County is actively partnering with the Union County Health Department and our Emergency Management Agency (EMA) to minimize community spread of coronavirus. As you may be aware, and at the request of the Union County Health Commissioner Jason Orcena, the Emergency Operations Center (EOC) was partially activated last week to provide coordinated communication and management of this public health crisis.

The purpose of this memo is to communicate the steps that the Commissioners are taking as a county to slow down or reduce community spread of the coronavirus and provide guidance for your office. We expect to issue additional memos, as information becomes available to further these purposes.

- Union County Veterans Auditorium

Commissioners Office: The Union County Commissioners Office will remain open for business; however, to limit exposure to the public and our staff, members of the public needing assistance should schedule appointments for necessary in-person access to the Commissioners Offices.
