A non-refundable fee of \$25.00 (check or cash) will be charged for each set of Contract Documents. Checks will be made payable to the Union County Engineer.

The owner intends and requires that this project be completed no later than September 10, 2019.

Proposals must be received by 11:00 A.M. local time, on Tuesday, March 26, 2019, in the office of the Board of Commissioners of Union County located in the County Office Building, 233 W. Sixth Street, Marysville, Ohio 43040. The proposals will be opened and read aloud immediately thereafter.

Each bidder is required to furnish with its proposal, a Bid Guaranty and Contract Bond in accordance with Section 153.54 of the Ohio Revised Code. Bid security furnished in Bond form, shall be issued by a Surety Company or Corporation licensed in the State of Ohio to provide said surety.

Each proposal must contain the full name of the party or parties submitting the proposal and all persons interested therein. Each bidder must submit evidence of its experiences on projects of similar size and complexity.

Disadvantaged Business Enterprise (DBE) Requirement. DBE participation goals (subcontracts, materials, and supplies) have been set on this project for those certified as DBE's in accordance with the TEA -21(1998) and 49 CFR, Part 26, and qualified to bid with ODOT under Chapter 5525 of the Ohio Revised Code (O.R.C.).
