CITIZENS ACADEMY

Citizens Academy offers the opportunity for members of the Sheriff's Office staff to work with our community, in hopes, to build a strong relationship with those we serve and protect. The Citizens Academy is made up of community members that take part in a 12 week program, meeting on Monday nights. This program helps participants gain a better understanding of the day to day responsibilities of the Sheriff's Office. During the program, participants learn about the history and our mission; the role of our Dispatchers, with a tour of our 9-1-1 Communications Center; the role and responsibilities of our Deputy Sheriffs and the Patrol Division, including crisis intervention, domestic violence, traffic stops, and accident investigations. They learn about our Support Services Division, Project Lifesaver Program, and the tracking device. Participants will spend time at the UCSO Range facility to learn about the Special Response Team and how the DRONE can help assist the Sheriff's Office. There will be a tour of the Investigations office while learning about the drugs in our community, crime scene investigation, interview & interrogation, photography, fingerprinting, DNA analysis, and identity theft. During the final weeks of class, participants will learn the responsibilities of our Court Services Division, court security, sex offender

registry, background checks, concealed carry permits, and prisoner transports; along with a tour of the Tri-County Regional Jail, and a ride along with a patrol Deputy.

A Note From The Union County Coroner's Office


David T. Applegate II, MD has been the elected and re-elected coroner since 2000. The office is staffed and available 24 hours a day, 365 days a year. There are two investigators in the office: Lead Investigator Lance Emberling, D-ABMDI, has been with the office since 2013. Investigator Jim Fish, D-ABMDI, has been with the office since 2015. Office secretary, Hope Jones, has been with the office for 59 years. Dr. Applegate and investigators Emberling and Fish are certified by the American Board of Medicolegal Death Investigators.

In 2017 the office became the 7^{th} coroner's office in Ohio to gain accreditation through the National Association of Medical Examiners.

The Union County Coroner's Office was notified of approximately 63% of all deaths that occurred in Union County in 2017. The office investigates all deaths reported in the county including Memorial Hospital, that meet the State of Ohio's criteria. The Montgomery County Coroner's Office performs our autopsies and toxicology. The coroner's office works closely with law enforcement, particularly the Union County Sheriff's Office and the Marysville Police Department for cases that may be criminal in nature.

Facts from 2017

- The Union County Coroner's Office collected 18.12 pounds of medication from scenes as a matter of evidence or for safe disposal.
- 296 death certificates were filed in Union County.
- 186 of the deaths filed in Union County were investigated by the Coroner's office (63%).
- 28 of the 186 deaths investigated were sent for autopsies.
- 56 of the 186 deaths investigated were referred to Lifeline of Ohio.
- Of the deaths investigated in Union County, the average age of death was 55 years old.
- 8 of the 186 deaths investigated were a result of an overdose.
- The average age of the overdose deaths investigated by Union County was 34 years old.
