Ohio's New (Demerit) Point System Law

(New Sec. 4507.40 and Amended Secs. 4307.15 and 1901.04 of the Revised Code of Ohio)

WHAT IT IS WHAT IT DOES

Ohio's point system is a new law passed by the recent 102nd State General Assembly and approved by the Governor. Through a system of assessing demerit points for traffic convictions on charges clearly spelled out in the law, it provides a means and an opportunity to remove the irresponsible driver from the road. It thus keeps the careful driver safe — and helps him to preserve his privilege to drive. BE THAT CAREFUL DRIVER! DON'T DRIVE FOR POINTS! DRIVE FOR SAFETY! SAVE YOUR LICENSE!

HERE IS THE LIST OF "DE-MERIT" POINTS.

LET IT SERVE AS A "WARN-ING" GUIDE TO YOUR SAFE DRIVING.

Manslaughter resulting from the operation of a motor vehicle

6 points Operating a motor vehicle while under the influence of intoxicating liquor or narcotic drug

6 points Failing to stop and disclose identity at the scene of the accident when required by law6 points Driving while operator's or chauffeur's license is under suspension or revocation 6 points Reckless operation in violation of section 4511.20 of the Revised Code or ordinance in conformity thereto, if based upon any factor other than speed 3 points Violation of any law or ordinance pertaining to speed2 points All other moving violations pertaining to the operation of motor vehicles reported under this section.

HERE'S HOW IT WORKS

2 points

(If you should become involved)

(1) Every county court judge; every

mayor (until Jan. 1, 1960); and every clerk of a court of record is required to keep a full and complete record of every traffic violation and conviction spelled out in the law (violations relative to parking a motor vehicle excluded).

- (2) Once you have been convicted in the court, a copy of that record will be forwarded to the Bureau of Motor Vehicles in Columbus for permanent "demerit" record on your "account" there.
- (3) If the total number of "demerit" points reaches six (or more), the Registrar of Motor Vehicles would send a warning letter to you.
- (4) When the number of "demerit" points total 12, "within a period of two years from the date of the first conviction within said two year period the registrar shall, within thirty days from the date of the last such conviction, file an application with the clerk of the court of common pleas in the county where such person resides or if the offender is a child as defined in section 2151.01 of the Revised Code, in the juvenile court in the county wherein such person resides, requesting suspension of such person's license or permit to operate a motor vehicle for a period of one year. Such application shall be accompanied by a copy of the registrar's record of the convictions and bond forfeitures of such person certified by the registrar.
- (5) Within ten days of such application for suspension by the Registrar of Motor Vehicles to the Clerk of the Court of Common Pleas (or Juvenile Court Judge, in case of a minor), a notice of a scheduled hearing on it would be sent to you by registered mail. The hearing itself must be scheduled within thirty days of the filing of the application.






