The Union County Budget Commission held a series of budget hearings with the Villages, Schools and Health Department.

The following members of the commission were present: Prosecuting Attorney Richard Pærrott and Auditor Warren G. Sutton - Treasurer Willard Clevenger was ill.

The Village of Richwood was scheduled to appear before the board at 9:00 A.M. but they did not come.

Mrs. Frances Fegley, Clerk of Magnetic Springs came into the room at 9:30 A.M. and after going over their anticipated receipts we (the board) suggested that they should watch their funds and at any time that they can, they should be idle funds on interest even for short times.

Mr. E. L. Alexander, finance director for the Village of Marysville came in at 10:00 AM., the same suggestion was made to him. Marysville due to the income tax has ample funds to finance their needs.

Mr. Ronald Hilbert, Clerk-Treasurer for Unionville Center was next at 10:30 AM They are in the unfortunate plight of needing everything that they can get to adequately finance even the smallest expenditures. The dump situation was discussed but until we hear from the townships nothing can be done.

Mr. Lowell Picklesimer, Clerk of Milford Center came in at 11:00 AM and they did not seem to have any particular problems. We discussed placing funds on interest for short terms. This could be a source of funds that could be used for necessary expenses.

Dr. Lloyd P. May, Sec'y of the Union County Health Board came in last before the noon break and if they are careful they will be able to get by on their receipts.

Break for Noon.

At 1:00 P.M. the Fairbanks School Board represented by Mrs. Barbara Dimond, Clerk and Mr. Galen Smith Kyre, Superintendent were seated and the finances and millage of the school were discussed. After hearing of the new value that had been placed on the tangible tax list it was agreed that they would ask for 2.00 mills on the November ballot.

At 1:30 P.M. the Marysville School Board represented by Mr. Frank C. Derby, Clerk and Mr. Leroy Williams, Superintendent came in and the same problems were talked about. Millages were discussed and Marysville is going to ask for an operating levy in November.

North Union School Board were the last for the day and were represented by Mr. Maynard McCloud, Clerk and Mr. Richard Fetter, Superintendent. They have grave problems and if the levys do not passithat will be voted on in November no one could hazard a guess as to the procedure that will have to WHATMANIAM MARKAMMAN follow.

The Union County Budget Commission held its regular annual budget hearings with the various townships on August 27th, 1970.

The following members were present for the hearings; Treasurer Kathryn Clevenger, Prosecutor Richard Parrott and Auditor Warren G. Sutton. Also, in attendance, was the examiner for the State Auditor's office Mr. Edward Gillett who explained to each of the townships as they appeared for their hearings the new law that had just gone into effect, that it was imperative that they now keep records of each of their employees so that in the future should they get employment in another government branch it would establish their seniority.

Allen Township was the first in attendance and were represented by the three trustees and their clerk. The matter of their fire-truck was discussed and they were advised to ask for an advance on their August settlement and pay off the note out of the General Fund and then replace this money out of the October settlement.

Claibourne Township was the next in attendance and they also had all four of their group present.

It was decided to place their millage for the Road Fund in the General Fund thus eliminating the Road Fund.

Mr. Parrott asked the Trustees to place a bid on the Waterman acreage for their cemetery expansion.

Darby Township was next and they were represented by their clerk and two of their trustees. Their budget was discussed in general but they seemed to be

Dover township were represented by their four members. The main item discussed was the possible purchase of ground for their cemetery. Also, discussed was the repairs to their township house which had been damaged in an auto accident.

Jackson Township was the to report and they were represented by the clerk and two of the trustees. Liability insurance was a point of discussion and also their cemetery was discussed.

Jerome Township came in and were represented by three trustees. About the only discussion on their budget was their fire contract. It was generally agreed that they could only go along with what-ever Plain City decided to do about their rates.

Millcreek Township was the last to appear before the noon break. Their three trustees were in attendance. Their clerk did not show. Their financial picture was in avvery healthy condition and it was decided that they would reduce their millage inside the ten mill limitation by .40 mills. They are to give the Auditor a resolution to this effect after their next meeting.

Noon break.

Leesburg Township was the first to appear after the noon break. They had three in attendance and about the only thing of importance discussed was their cemetery and the price of their lots and the charge for their graves. Liberty Township was represented by their clerk Mr. Gene Smallwood and two of their trustees. Their cemetery was discussed as to the price of the lots and the charges for the opening and closing of the graves. In view of the fact that their balances were declining it was suggested by Mr. Gillett that their accounts should be looked at carefully. If the decline was because of some special charge that was one thing but if not then some thought of placing the issue before the electorate should be given.

Paris township was represented by their clerk and one trustee (Louis Lee). They were notified that they must close their dump. It was decided to drop .50 mills from the tax duplicate. Resolution must be given the Auditor's office.

Taylor township had three in attendance for their hearing. Their budget was discussed in general and in their case also they were advised that the millage for the Road Fund should and would be moved up to the General Fund. Union Township was the last for the August 27th meetings and they had three in attendance. Their fire fund came in for discussion and they were advised that they could purchase the TRUCK CHASSIS & CAB MMANNAMANNAMAN from their gasoline fund. The balance, however, must be paid out of the Fire Fund. This concluded the first day of hearings,

The Union County Budget Commission held its second day of annual budget hearings with the balance of the townships, municipalities and school boards. Washington Township was represented by three members and it was decided that they would like to have .50 mills put on their duplicate inside the ten mill limitation. They agreed that they would present a resolution to that effect. York Township presented themselves and had all four members in attendance. Their .40 mills for the road fund will be moved to the General Fund thus eliminating their Road Fund. They were advised by Mr. Gillett that their old stone bills, appropriations and miscellaneous papers could be destroyed back to the last two audits.

The village of Richwood did not come to the meeting.

Mrs. Fegley brought her budget to the meeting and she was advised that it would be mailed to her after it was checked. She is the clerk for Magnetic

Springs, Ohio.
Mr. Paul Willeke and Mr. Brubaker were present for the Marysville Corporation. Their budget was left as it was filled out.

Mr. Ronald Hilbert, Clerk for Unionville Center, presented his budget and was *advised that it would be mailed back after it was filled out.

Mr. Maynard McCloud and Jesse Conrad represented thamselves for the North-Union School District after the noon luncheon break.

It was decided that they would ask for a reduction on their bond millage for next year. The budget commission reduced the bond millage to 7.80 mills because of the .03 expiration.

Mrs. Barbara Dimond and Mr. Galen Kyre represented the Fairbanks School District and after discussion on their bond millage it was decided to reduce their millage by one mill (1.00) if the board should decide unaminusly to do so by resolution to the budget commission.

Mr. Frank Derby and Mr. LeRoy Williams were present for the Marysville Exempted School District and after much discussion it was decided that they also would reduce the millage in the bond fund. This of course would have to be passed unamiously by the board in session and a copy of the same given to the auditor's office. The proposed reduction would be a mill.

This concluded the budget commission hearings for the year 1970 with the exception of the libraries.

The 1971 Budget Commsiion hearings for the year 1971 were held in the Union County Commissioners with Treasurer Kathryn Clevenger, Ass't Prosecutor Robert Hamilton (in the mornings) and Asst Prosecutor Gary McKinley (in the afternoon) along with the Auditor Warren G. Sutton attending each session. At 9:00 AM the first township (Allen) was represented by their Clerk and the three trustees. Trailer Court and Licensing regulations were discussed. It was agreed that something must be done. Their budget was not changed from the figures that had been presented.

9:30 A.M. and the next township called was Claibourne. V. Zuspan, Clerk and two trustees were present. Their budget was not cut but allowed to stand for the year (calender) 1972. Cemetery Lots were discussed both as to price as

well as acquiring acreage.

10:00 AM MMM Mrs. Zimmerman, Clerk was present along with two trustees. The matter of fire protection was discussed and the Prosecutor informed Mrs. Zimmerman that inheritance money could be moved or placed in any account that they felt the need for. Thier budget was accepted pmmm as presented because of the large amount of Penn Central value in their township.

10:30 A. M. Dover Township was the next called. Mr. Paul Low, Clerk Treas along with the three trustess attended the meeting. Because of the Dover Acres Trailer Court and the Hankins Housing Development in the Watkins area, the trustees were concerned about POLICE protection that they might be called upon to hire. The Budget Commission decided not take any action on their budget but to

accept the figures as they were presented.

11:00 A. M. The next township in attendance was Jackson. Mr. Clyde Carter, Clerk and the three trustees attended the hearing. After some discussion it was agreed to cut their budget by 0.20 Mills on the Inside Millage for the next year. The Commission was in agreement that this would be held for the Turstees in case the need might present itself for reinstatement.

11:30 A.M. and the last township for the morning session was Jerome. The three trustees were present. After some discussion it was agree that the Commission would cut 0.20 Mills from the Inside Millage and 0.20 Mills from the Fire Levy for the year 1972 (calender). Again, the Commission agreed that this cut millage would be reinstated if the need presented itself.

RECESS FOR LUNCH.

1:00 P. M. The first Township in attendance for the afternoon session was Leesburg. Three members were in attendance. After some discussion it was agreed that their budget would be cut 0.20 Mills for the coming year. Again, this would be held for their account if the need should present itself.

1:30 P. M. Liberty Township was represented by their three Trustees. After some discussion it was agreed to cut their millage also by 0.20 Mills for

the next year. If the T. R. C. acreage loss would be too severe it was decided that next year that this could be given back to the Trustees for Township

operation.

2:00 P. M. Millcreek Township was the next to come in and after looking over their prospects for the coming year the Commission felt that their budget could be cut by 0.50 Mills. Again it was pointed out that this millage would be held for them in case that the need should present itself in the future. 2:30 P. M. Paris Township was represented by two Trustees. Because of their favorable situation it was agreed to cut their Inside Millage by 0.10 mill. This was agreeable by all in attendance.

3:00 P. M. Taylor Township came in for their meeting and they were represented by their clerk and the three trustees. The Commission agreed to allow them to increase their inside millage to 1.20 mills for the year. They would be

looked at real hard for the next years balances.

3:30 P. M. Union Township was the last for Thursday November 18th and they were represented by Libbie Johnson Clerk and two Trustees. After MMMMMMMM discussing their Cemetery needs and going over their statement it was agreed that the Commission would cut their millage by 0.20 Mills inside.

The first Township (Taylor) scheduled to appear was Taylor and in attendance was the three trustees and the clerk. Mr. James Pierce (State Examiner) was in attendance for all sessions and gave budget help to all that requested it. Taylor Township Budget was accepted by all board members.

The next township (Allen) was present and all four members of the Board sat in on the meeting. They have no particle problems and agin several things were discussed and the Budget Commission accepted their budget as presented. Claibourne Township was the next scheduled Board of Trustees and they were represented by the three Trustees and the Clerk. Their budget was discussed at some length and they felt that they must submit a levy for the consideration of the voters on the November ballot. The Budget Commission accepted their budget as presented.

The next township (Darby) scheduled for appearance was present on time and were represented by the three trustees. Their budget came under special attention because of the fact that they are showing a steady drop in finances. The Budget Commission tried to explain that they must watch their expenditures since the rate of depletion of finances is showing such a drastic drop in these two years. The Commission accepted their budget after the above discussion.

Dear Budget Commission Members:

In anticipation of the budget hearing for the Fairbanks Board of Education on its 1974 budget, there is certain information that the Board of Education requests the Budget Commission to provide at that hearing. The information is as follows:

Personal Property

1. What was the taxable personal property valuation of the Goodyear Tire and Rubber Company upon which taxes were assessed and collected during 1972? In 1973? 2.989.4470

2. What is the taxable personal property valuation of the Rockwell Plant upon which taxes were assessed and collected during 1973? 5,950,380

3. For tax purposes, what classification are the breeding bulls of Select Sires, Inc.? It has been reported that attempts were being made to classify these animals as farm animals, thus avoiding any tax on them.

4. According to our notes made at the budget hearing on the 1973 budget, it was noted that no personal property valuation of Rockwell were included in the \$4,425,652 printed on the budget and used to project revenue. These values were to be added when they became available. Are they available now?

5. The personal property values found on the 1974 budget shows only \$3,681,956. This is \$743,696 less than 1973 without Rockwell. This appears to be a very substantial drop. What reason is there for this which of a drop? Consider that personal property is assessed at 50 percent, this represents a loss of over \$1,487,392 in appraised personal property values.

Real Estate

1. What is the 1973 real estate valuation of the following pro-Archive 1,620,190 perties, Goodyear, North American Rockwell, Select Sires, Inc.?

2. Goodyear has added an addition to its plant. It appears completed. Has an appraisal been made and when will it be placed on the tax duplicate?

3. At the 1973 budget hearing, it was said that new construction was not included in the real estate values. What was the new construction figure for 1973?

Public Utilities:

1. Are Penn Central Valuations removed for the 1974 budget?

2. The power company installed new towers and lines in Union County and Fairbanks School District. Have these been appraised? When will these valuations go on the duplicate?

1973 Tax Collections:

- 1. We do not fully understand the reasons for the delay in tax collections and distributions of tax money so far this year. Could you give us an emplanation of the kinds of problems you faced so that we can relay them on to others who question why the district is borrowing so much money from the bank?
- 2. As previously noted, at the 1973 budget hearings it was pointed out that personal property values of Rockwell were excluded, and that new construction values were excluded from the values used to project revenue. By this time, new construction values are known, and soon, if not already known, is the Rockwell valuation. Can the Board of Education assume with accuracy that more money will be collected than was anticipated at that budget hearing?
- 3. Were there any appeals to the County Board of Revisions or to the State Board of Tax Appeals by taxpayers for a reduction of valuation in 1973? If so, about how much were values reduced?
- 4. Homestead exemptions reduce the amount of taxes collected. How much taxes are lost due to homestead exemptions in Fairbanks School District?

The Board of Education realizes that these questions may require considerable research on the part of the auditor and treasurer, however, it is very important for the Board to have an understanding of its local tax base. Please refer any questions you may have to the Superintendent, Galen Kyre.

I have just recently received from the Department of Education the State Foundation form, SF-12 which contains the Fairbanks School District tax valuation for 1973. The valuation was \$28,258,970.00 which did not include all of Penn Central's valuation. I checked with the State Department of Education and with the Department of Taxation, Division of County Affairs, Dale Teeters, and both acknowledged that the tax valuation including all of Penn Central is \$28,649,575.00.

Mr. Teeters said that included in the tax valuation was \$4,528,925.00 in 1972 personal property, \$4,400,111.00 in Union County and \$128,814.00 in Madison County.

This would leave \$24,110,650.00 in real estate and Public Utilities to be taxed in 1973. Since personal property is listed and taxed currently, I would need to know the current (1973) personal property to estimate the tax duplicate you are collecting in 1973. Together this would update my valuation figures and permit me to reassess my anticipated income for the last half of 1973.

In regard to the 1974 tax budget, and the valuation placed on the budget, the total is \$24,032,540.00. I noticed Union County personal property down from \$4,425,652.00 in 1973 to \$3,681,956.00 in 1974. In respect to 1974 estimated values, the reported increase as cited by the Department of Taxation would lead me to believe that this is likely to increase also.

In response to your request via the letter to the budget commission received from Mr. Kyer, I have the following information. The valuations for all the 1972 Intercounty Corporation in the Fairbanks Local School District should be available on your duplicate. The 1973 Intercounty valuations are due to be mailed out to the counties during the week of August 13, 1973. To discern whether or not the construction in progress for Rockwell International that Mr. Kyer mentioned has been returned this year, I suggest that you contact the Intercounty Personal Property Tax Division, since they hold the files on all Intercounty Corporations.

Select Sires Inc. has filed a 1973 Personal Property Tax Return. They made an error however. They filed in Franklin County where they have been filing for several years. Their location merely changed in 1972, thus no new taxpayer return would be due from them for 1972. Almost all of their operation is listed as agriculture and declared by them as exempt from personal property taxation. The Department of Taxation is in process of building an investigation of Select Sires in an attempt to reclassify much of that which is currently listed as agricultural. To start the investigation on even ground it would be appreciated if you would accept the 1973 Personal Property Tax Return of Select Sires Inc. as timely filed in Union County under an extension granted by Franklin County.

According to your placement of Select Sires Inc. mentioned in our telephone conversation of August 13, 1973, in Jerome Twp.-Washington LSD/Franklin Co., Mr. Kyer of the Fairbanks Local Schools will not receive any millage from this firm. All applicable scholl millages will be distributed by you to Washington Local School District in Franklin County.

Union County Budget Commission held their meeting in the Commissioner's room August 30th & 31st for the purpose of hearings on the Township & School & City & Village Budgets.

Allen Township was the first township to be called and they were represented by the Clerk-Treasurer and two of the Trustees.

In order to bolster their revenue it was suggested that they keep their funds on savings. That they should have at least \$10,000. in certificates.

Also, house trailers were discussed and the Auditor suggested that he would send

a slip to be mailed in once a month.

The Trustees seemed to be satisfied with the progress they were making and said they were using revenue sharing monies for their township house .

Claibourne Township was the next to appear and they were represented by the Clerk-Treasurer and three trustees.

They were informed that their allotment of gasoline monies would be \$14,200 for this year. We also asked them to keep more of their funds on interest in order to help their general fund.

The question of emergency ambulance service was discussed as well as their disposal of the revenue sharing monies. They are using for cemetery. Their financial condition was not considered in a bad way at all.



The Union County Budget Commission was called into session with the following in attendance Auditor Elect Mrd. Eloise Dowell - Gary McKinley, Prosatty, Mrs. Tomia Lowe, Treasurer and Warren G. Sutton, Auditor.

Mr. McKinley opened the meeting by announcing that the meeting was called for the purpose of examining the various budgets in the county.

The meeting opened at 8:45 A. M. and the first summoned was the County Health. Dr. May was present for the Board and the only question that he asked was without the mileage rate that was being allowed. He was told that mileage allowed is now 15ϕ per mile.

Allen Township was the next on the list and they were represented by Mr. Joe Wells and Mr. J. W. Carlyl. They brought up the question of their ability to get by on the factored millage. After it was shown the monies that they would get from the I. S. Millage they felt that they would not be in too bad a straights. The millage mentioned above was for the fire equipment that they had purchased.

Claibourne Township came in at 9:15 A. M. Mr. John Bell, Mr. Duane Stilling and Mr. Paul Wiley attended for them. They were concerned with their levies. Their cemetery expenses were of a concern to them. We explained their increase in revenue brought about by the revaluation and the fact that the I. S. Millage was not factored should give them ample revenue. No levies for this year.

At 9:30 Dover township appeared before the board. They were represented by Mr. Lloyd McDowell and Mr. Paul Low. They informed us that their Township House Plans had been approved. It is to be built on the site of the school-house that had been razed in New Dover. At this time they said that they had ample funds and that no levies were planned.

Darby township came in at 9:45 A. M. and were represented by Mr. Ralph Burns and Mr. Emerson Boerger. A fire levy was discussed. It will be placed on the ballot for collection in 1979.

10:00 AM and Jackson was the next township to appear before the Budget Commission.Mr. Clyde Carter, Mr. Chas MMMMMMMMM Sivey and Mr. Robert Harrison were in attendance. They do not anticipate placing any levies on the ballot for this year. The matter of interest on the Revenue Sharing Fund was discussed at length. They were advise to figure the interest on this account and place it in this fund.

Jerome Township came in at 10:15 and were represented by Mr. John Bishop, Mr. John Mercer and Mr. Paul Davis. We could not talk too much because they did not have their budgets ready for us. There had been a mistake in their voted millage because of the factor and the fact that we should have used last years appraisal values.

At 10:30 A. M. Leesburg Township came in and were represented by Mr. Russell Lowe, Mr. Gary Cunningham and Mr. Merle Robinson. They do not anticipate placing any levies on the ballot. They are concerned about their fire expense. We told them of the extra funds they would be receiving from the I. S. Millage and also how they could increase their interest if they would just keep their funds on interest.

Emmit Rogers and Mr. Eldridge Thomas came in at 10:45. They talked of 0.20 mills for additional funds and they were shown that there had been an error in computing their revenue for this year and they agreed to wait until next year and see how their funds were holding up. We also talked of the post-office going into their building that might jeopardize their exempt status of their building.

Lawrence Liggett, Merle Neill, Robert Casper and Mr. Howard Heidorn presented themselves for the Millcreek Township hearing. They do not figure to place any levies on the ballot for the year. They show a good healthy balance in their accounts and do not anticipate any difficulty with their finances.

They have a very nice tax base to operate with.

Paris Township came in at 11:15 A. M. to go over their budget. We, again, stressed the value of keeping their invested. They do not intend to place any levies on the ballot. They are in very good shape financially and probably will keep on in this condition. They were represented by their new Clerk-Treas. Mrs. Debbie Streng and Mr. Lowell Wilson.

Taylor Township was represented by Mr. Wm. Liebold, clerk-treasurer, Ronald Steele and Willard Willson. They felt that they could not get along with the 0.60 mills that we had given them the year before. After some discussion it was moved by Gary McKinley and seconded by Tomia Lowe to raise their I. S. by 0.30 to 0.90 mills I. S. On a Roll call vote Tomia voted Yes.

At 1:45 P. M. Mr. Tucker Smith, Clerk-Treas for Richwood came in for his budget. He was given his budget for this year and informed us that they did not anticipate placing any levies on the ballot for this fall.

At 2:00 P. M. Mrs. Anne Tucker, Clerk-Treas. for Magnetic Springs presented herself and picked up her budget. Mrs. Tucker explained that they were having h rough time keeping their streets in repair.

At 2:15 Marysville was scheduled and Mr. Willeke, Paul and Roberts, Dick the City Manager presented themselves. They informed us that Council had approved a 2.00 mill levy but the Budget Commission could not see the reason behind this thinking. In view of the recall movement that had just passed and the troubles that the Auditor had gone through it was decided that if and when they (the City of Marysville) started any major building program then we (the Union County Budget Commission) could and would restore some of the millage that had been removed in the past. Council had promised no tax increase for this year. The Millage for the Bond Fund has to be refractured.

Unionville Center was the next village scheduled and Mr. Ronald Hilbert Clerk-Treasurer was present. Mr. Hilbert informed us that they were paying their lighting assessment out of the general fund. They are going to place a levy on the ballot for the 1979 tax collection year.

Mary Ann Brill the Clerk-Treasurer for Milford Center came in at 2:45 P.M. She picked up their copy of the budget and informed the Commission that they (Milford Center) had not particular financial problems.

Fairbanks S.D. came in for their hearing at 3:00 P. M. Mrs. Gruenbaum, Galen Myre and the President of the Board were inattendance. They do not anticipate putting any levies on the ballot for this year. They were wondering about the inter-county returns but at this time we could not give them any answers.
