MEETING MINUTES

May 13, 2025

The Union County Airport Authority held its regularly scheduled monthly meeting on Tuesday, May 13, 2025. This meeting was held at the Union County Airport, 760 Clymer Road, Marysville, Ohio and was called to order at 4:00 pm by Vice President Philip LaPointe. Members present were Mr. Steve Koenig (Teams), Mr. Bob Chapman, Mr. Ken Denman, Mr. John Popio, and Mr. Shaun Bailey. Guests present were Mr. David Gotschall and Dave Wall of Woolpert, Mr. Steve Wieringa of SkyVista, Mr. Kyle Meddles of Marysville Journal Tribune, and Mr. Tom McCarthy of Union County Commissioners.

Mr. Bailey motioned to accept the April minutes as presented. Mr. Chapman second. Motion passed. Mr. Chapman motioned to accept the \$10,642.89 in funds needed for the May bills to date. Mr. Bailey second. Motion passed.

Mr. Koenig reported that all paperwork has been signed for the Coleman's Crossing Roundabout and should be receiving a check soon from the City of Marysville. The Box Hangar contract is in Thayne's hands and may have a special meeting to go over the contract.

Mr. Wieringa of SkyVista reported that a new water sump pump was purchased and installed. Purvis may stop producing the filters needed for the AVGAS and Jet Fuel within the next couple of years. SkyVista is looking into the shelf life of the filters and may purchase some to have on hand. Eubanks Electric came out and fixed a camera and Jess Howard Electric came out and fixed 0927. Silco is scheduled for May 30 for the back flow test. The FCC License has expired and Woolpert is working with Mr. Koenig on it. Mr. Wieringa would like to give the tenants more of a heads up on hangar rates for 2026. Mr. Wieringa also discussed SkyVista's concern about the security of the airport. He was going to change the code to gate. May look at adding more cameras and also getting a quote for fencing. Mr. Wieringa also reported that the cracks on the ramp are getting worse and crack sealing will not work.

Mr. Rausch had previously send an estimate for Rausch Enterprises to fertilize and weed kill the Turf Runway. Mr. Bailey motioned to allow Rausch Enterprises to fertilize and weed kill the Turf Runway not to exceed \$2,278.80. Mr. Denman second. Motion passed.

Mr. Gotschall reported from Woolpert (see attached).

Mr. Denman motioned to adjourn the meeting at 4:42 pm. Mr. Bailey second. Motion passed. The next meeting will be on Tuesday, June 10, 2025 at 4:00pm (EDT).
