<p><b>Issue 2</b> <b>Proposed Constitutional Amendment</b> <b>TO FUND PUBLIC INFRASTRUCTURE CAPITAL IMPROVEMENTS BY PERMITTING THE ISSUANCE OF GENERAL OBLIGATION BONDS</b> <b>Proposed by Joint Resolution of the General Assembly To enact Section 2t of Article VIII of the Constitution of the State of Ohio</b> <b>A majority yes vote is required for the adoption of Section 2t.</b></p>	<p><b>All Precincts</b></p>
<p>This proposed amendment would:</p> <ol style="list-style-type: none"><li>1. Authorize the state to issue bonds or other obligations to finance or assist in financing public infrastructure capital improvements for local governments and other governmental entities. Capital improvement projects would be limited to roads and bridges, waste water treatment systems, water supply systems, solid waste disposal facilities, storm water and sanitary collection, storage, and treatment facilities.</li><li>2. Determine that such capital improvements are necessary to preserve and expand the public infrastructure, ensure public health, safety and welfare, create and preserve jobs, enhance employment opportunities, and improve the economic welfare of the people of Ohio.</li><li>3. Limit the total principal amount of the state general obligations issued under the amendment to no more than \$2.5 billion over a ten-year period. Any principal amount that could have been issued in any prior fiscal year, but was not issued, may subsequently be issued.</li><li>4. Require that obligations issued under this amendment mature no later than thirty (30) years after their date of issuance, and that any obligation issued to retire or refund other obligations mature no later than the permitted maturity date for the obligations being retired or refunded.</li><li>5. Authorize the General Assembly to pass laws implementing this amendment, including laws establishing procedures for incurring and issuing obligations, and laws providing for the use of Ohio products, materials, services and labor to the extent possible.</li></ol> <p>If approved, the amendment shall take effect immediately. INITIATIVE, REFERENDUM, ANDRECALL OF THE CHARTER FOR THE CITY OF MARYSVILLE TO ALLOW A REFERENDUMPETITION ON ANY ZONING OR ANNEXATION ORDINANCE TO BE FILED WITHIN SIXTY (60) DAYS AFTER PASSAGE AND ANY SUCH ORDINANCE MAY NOT BE PASSED BY EMERGENCY.</b></p> <p>Notwithstanding any other provision of this Charter or Ohio Law, a referendum petition on any Zoning Ordinance or Annexation Ordinance to rezone or annex property may be filed within sixty (60) days after passage by the Council of the Zoning Ordinance or Annexation Ordinance, in order to afford an opportunity during that period for the filing of referendum petitions thereon. Notwithstanding any other provision in this Charter or Ohio Law, a Zoning Ordinance or Annexation Ordinance shall not become effective prior to sixty (60) days following its passage by Council, in order to afford an opportunity during that period for the filing of referendum petitions thereon. Notwithstanding any other provision of this Charter, no Zoning Ordinance or Annexation Ordinance shall be passed by Council on an emergency basis. "Zoning Ordinance" for purposes of this Section, means any legislation passed by Marysville City Council that changes the zoning classification or changes the use of property in the City. "Annexation Ordinance" for purposes of this Section, means any legislation passed by Marysville City Council that takes property located in an unincorporated area of a township and makes the property a part of the City of Marysville. **INSTRUCTIONS TO VOTER FOR INDICATING YOUR CHOICES ON A FEDERAL WRITE-IN ABSENTEE BALLOT (FWAB):**

To complete a Federal Write-In Absentee Ballot (FWAB), go to [www.fvap.gov](http://www.fvap.gov). You have the option of downloading a blank, hard copy FWAB to complete by hand, or proceeding through electronic completion of the FWAB using the website’s FWAB Wizard.

The first page of the FWAB is a Voter Declaration/Affirmation you must complete in order for your ballot to count.

After completing the Voter Declaration/Affirmation, use the initial election notice issued on the 100<sup>th</sup> day before the election and the updated election notice issued on the 46<sup>th</sup> day before the election as a guide to:

- (1) write the name of each candidate or issue contest for which you are casting a vote and then
- (2) write the name of your choice of candidate or choice for or against an issue.

After you have completed the FWAB, **you must PRINT the ballot and MAIL it to your county board of elections at this address: Union County Board of Elections, 835 E. 5th St, Suite A, Marysville, Ohio 43040.**
