1. Call to Order

Chairman Dean Cook called the meeting to order at 9:30 a.m.

2. Approval of Minutes

3. Approval of Bills

5. Budget Report

Deputy Director Forrider presented the year-to-date budget. The Board had no questions or concerns.

6. May 2025 Special Election Chargebacks

The Board of Elections was able to charge back \$56,000 from the costs of the May election. The Board reviewed the chargebacks and motioned for approval. Motion by Rich Coglianese, seconded by Fred Vogel. Motion passed unanimously.

7. Candidate Petitions – for the November 4, 2025 General Election (see attached list)

The staff presented the petitions for the Board's approval. All the presented petitions were reviewed and verified by the Board of Elections staff.

The following two petitions were recommended for rejection due to various reasons:

Jason Hollingsworth - Petition did not have enough valid signatures

Tony Ackley - Petition was deemed invalid due to incomplete form.

Motion to reject by Fred Vogel, seconded by Barbara Luke. Motion passed unanimously.

The following petitions were recommended for approval:

Municipal Offices - Motion for approval by Rich Coglianese, seconded by Fred Vogel. Motion passed unanimously.

Members of Board of Education - Motion for approval by Rich Coglianese, seconded by Fred Vogel. Motion passed unanimously.

Union County Trustees and Fiscal Officers - Motion by Fred Vogel, seconded by Rich Coglianese. Motion passed unanimously.

8. Questions and Issues for November 4, 2025, General Election (see attached list)

The staff presented the questions and issues to be added to the November General Election ballot. All have been reviewed and approved by the Ohio Secretary of State.

Approval of charter amendments motioned by Fred Vogel, seconded by Rich Coglianese. Motion passed unanimously.

Approval of the Tax Levies was motioned by Barbara Luke, seconded by Fred Vogel. Motion passed unanimously.

Approval of local liquor options motioned by Barbara Luke, seconded by Fred Vogel. Motion passed unanimously.

9. KnowBe4 Training

All Board Members must complete their Security Awareness Training as part of the Secretary of State's security directive. All training must be completed by the end of September.

10. Precinct Maps

Director Clay and Deputy Director Forrider presented new precinct maps that will go into effect for the November General Election. Two new precincts have been added. Motion to approve the maps by Rich Coglianese, seconded by Fred Vogel. Motion passed unanimously.


11. New Server and Meraki

There are two large purchases that will need to take effect before the November election. The Board of Elections server has reached its end of life and will need to be replaced. The funds for the server have already been incorporated into the 2025 budget. A new Meraki firewall and access point are also needed. The replacement appraisal is \$5,000, and funds will be paid through a security grant provided by the Secretary of State. Motion to approve the purchases by Barbara Luke, seconded by Fred Vogel. Motion passed unanimously.


12. Miscellaneous
