Andy is currently serving his 3rd term on the Board




Cheryl is currently serving her 2nd term on the Board

Tallgrass Truths—Revealed! Management is your Friend...

Landowners, there is nothing wrong or "illegal" with mowing random and curving "hunt trails", or walkways, through the voluntary Conservation Reserve Program (CRP) grassland practices. It is always best to mow to an eight-inch height. Hunting trails that wind through the tall and thick vegetation will not place the landowner in "non-compliance" with the voluntary conservation practices' contracts.

Up to 20% of your acreage can be mowed per year under your contract without penalty. If done in sections or strips, this will not only open up the field for wildlife to use but will also open it up more for you to use and be easier to hunt. Be sure to address any woody vegetation growth during this mowing opportunity

Common Milkweed Seed Collection





Union SWCD, 18000 ST RT 4, Suite D is an official drop off site for the Ohio Pollinator Habitat Iniative (OPHI) Milkweed collection.

Union SWCD office hours are M-F 8:00am - 4:30pm

There is a bin outside of the office door to collect Milkweed Pods after hours.

The collected seed will be cleaned and offered back to the public for use in plantings to help rebuild habitat for monarch butterflies and other native pollinators in Ohio.

Milkweed is the only host plant for the Monarch butterfly for egg laying and caterpillar rearing. It also serves as a food source for Monarchs as well as many other pollinator species.

The disappearance of milkweed across the U.S. has contributed to the 80% decline of the eastern Monarch butterfly population over the last 20 years.

We are working hard to change this, and you can help!

Let's make our collection efforts in 2025 even better by following these simple tips!

- Make sure that before you collect seed, you become familiar with the Common Milkweed to avoid harvesting pods from similar plants such as hemp dogbane and swamp milkweed.
- It is best to collect pods when they are dry and grey or brown. IT IS IMPORTANT TO CHECK!
- If the center seem pops with gentle pressure, they can be harvested.
- Store the pods in PAPER bags; plastic bags collect unwanted moisture.
- Put the date and county collected on the bags when you turn them in.
- Keep the pods in a cool, dry area until you can deliver them to the nearest collection site

Technical Trivia: Erosion Control Blanket (ECB)

Covering conservation and drainage topics on a quarterly basis.



Erosion Control Blanket (ECB) may be single or double-netted using a mulch medium comprised of straw, coconut fiber, straw/coconut fiber, wood excelsior, or equivalent material. It is used to stabilize freshly graded soil so that a newly grass sown area can become established, especially in highly erodible locations. It is installed with 6" landscape staples and the rolls are overlapped like shingles on a house roof to shed rainwater properly. When installed correctly versus just spreading straw, they can be the difference between a successful stand of grass and failure leading to erosion and bare, exposed dirt.

Stormwater Management: Gray & Green

In the world of stormwater management, the terms "gray" and "green" infrastructure are often used to distinguish between different ways of managing stormwater. Both approaches are interesting, useful, and have their own pros and cons.

GRAY:

"Gray" infrastructure is a more conventional way of dealing with stormwater. It uses engineered systems like pipes, concrete channels, or storm sewers to move stormwater away from developed areas and into bodies of water—usually local streams or rivers—as fast as possible. The use of concrete and other traditional building materials is why this approach is nicknamed "gray".

PROS:

Moves stormwater quickly.

Modular and effective for large projects.

CONS:

Dumping stormwater into water bodies that fast can cause erosion.

These systems can carry pollutants directly into water bodies. Undersized systems can lead to flooding and property damage.

GREEN:

"Green" infrastructure is a newer and nontraditional way of dealing with stormwater. It uses natural features, like plants and soil (hence the nickname "green"), to manage stormwater where it falls. This is often done through rain gardens, permeable pavements, or bioswales that absorb, filter, and retain stormwater, allowing it to infiltrate into the soil.

PROS:

Mimics natural processes. Soil and plants naturally filter pollutants, improving water quality. Can enhance urban environments by reducing the heat island effect and providing aesthetic value.

CONS:

While maintenance costs are similar to landscaping in a park, the above benefits are not factored into traditional cost-benefit analyses, making these systems seem less

Undersized systems can lead to flooding and property damage, similar to gray infrastructure.
