Elected Officials/Department Head Updates:

- Andy Smarra had no report.
- Eric Phillips stated there is an Economic Forecast Event on Thursday, March 27. It will be at 8:00 a.m. at the AMIC. There will be a good presentation.
- Brad Gilbert stated March 16 March 22 is Severe Weather Awareness Week in Ohio. On March 19 at 9:50 a.m. there will be a statewide tornado siren. There will also be a tornado drill for staff on the 19th as well. It is not mandated.
- Adam Negley stated Mental Health and Recovery is partnering with the Avalon Theatre for a session called Empowering Parents in the Digital Era. There will be some researchers from the University of Dayton there to talk about the younger generation and social media use. This event will be on Wednesday, March 12 at 6:00 p.m. and it is free for the public. The Prevention, Awareness and Support Services Agency will host a one-day training on mental health first aid on Saturday, March 15 at Our Ladies of Lourdes Parish. This training is open to the public. NAMI MidOhio, National Alliance on Mental Illness, has established a prenatal and postpartum support

- group. The first event is March 11, and will be held at the Health Department. All information about this event can be found at the NAMI website.
- Ginger Yonak stated National Employee Appreciation Day is Friday. Employees can stop by Coffee Hall or Kitschen Bakery for a free treat. Employees must bring their ID to get the treat. Last week was the first BMI educational workshop. There will be four more, and there will be both virtual and in person ones. Lunch will be provided at the in-person events. The Wellness program ends in June. Employees must get a physical exam and complete \$50 of Anthem Rewards to get the Wellness discount, and spouses only need to complete the physical exam. The Sydney Health App does offer virtual appointments, and the Health Department now offers preventative care services.
- Brad Bodenmiller stated the County Comprehensive Plan public hearing is on March 12. He will
 be sending the agenda and resolution drafts later today. The state is potentially eliminating the
 Rural Transportation Organizations funds. Richwood has received funds for sidewalks, so local
 communities could be impacted by this change. He is encouraging the community to reach out to
 local representatives regarding this change.
- Karen Elyon stated the 80% ADR for occupancies is from Honda. There is a conference next week for the state association about short-term rentals. The annual tourism breakfast is Thursday, March 20

The task force meets this morning at 9:30 a.m. at the Union County Chamber of Commerce. Updates include:

- · Awaiting word on grant submission.
- Honda Heritage Center is now a participant in the Fourth Grade History Pass
- Working with Marysville Art League leadership to apply for their participation in the Creativity Trail that launched in February.
- Working through the process for Union County murals to be submitted to the mural trail.

Other

- The Union County Tourism annual breakfast meeting will be held on Thursday, March 20 at 8 a.m. at the Grain Wedding & Event Center.
- Brandon Clay stated the Board of Elections is preparing for the May 6 election. There is only one state issue, but multiple school and township levies. Their website has a list of all issues that will be on the ballot. Sample ballots will possibly be up next week. Overseas and military ballots will go out March 21, and early voting begins on April 7. That means the voter registration deadline is April 6. The deadline for the November 6 election is August 6. The Board reorganization meeting is later today, and this year there are two new members.
- Mike Justice stated that Balloon Festival is not happening this year, but the fair will have a concert on August 2. The Union County Sheriff's App is updated and working. It will now include the jail roster, and "submit a tip" for schools.
- Judge Rodger encouraged everyone to attend the Empowering Parents in the Digital Era event. He stated the annual report will be coming out soon. Probate and Juvenile Court applied for a grant for a software update. He is hopeful they will receive that.
- David Phillips stated there is a three-day trial this week, and there will be another one next week. He has been reviewing House Bill 315 and looking into the changes that impact townships and other departments. His office is working on the delinquent tax list and has collected over \$300,000 of delinquencies. Some properties are going to sale, and others are going into payment plans.
- Wendy Golden stated Judge Fraser is on day two of a three-day trial.
- Bill Narducci stated the logiam project is moving forward, and there will be an update provided on that during a regular Commissioners session in the next couple of weeks.
- Thayne Gray had no report.
