Elected Officials/Department Head Updates:

- Janell Alexander stated August is Child Support Enforcement Month. The Courthouse tower will be green to honor this. Senior Day at the Union County Fair went very well. It was great weather, and they ran out of meals. They will plan more meals for next year.
- Brad Bodenmiller stated there have been nine subdivision plats submitted this month. This is the most they have ever received in one month. They are currently reviewing Mill Creek Township's Comprehensive Plan. There was a feasibility study conducted on the bike path between Bellefontaine and Urbana on how to improve the paving in that area. They used their RTPO funds to apply for funds to pave that stretch of the bike path instead of using chip seal.
- Andy Smarra stated tax collection period is officially over. Commissioner McCarthy asked for a
 copy of the revenue report that includes the real estate taxes that were collected in 2025, and Mr.
 Smarra said he would get that once it was available.
- Karen Eylon stated the America 250 Celebration Trail has launched and includes 64 stops. Festifair will be on September 6th, and it continues to grow every year. Occupancies at hotels in Union County are still higher than average. This is due to Honda. Work continues on the wayfinding signage project, but it is moving along.

- Magistrate Adam Reinhart stated Judge Rodger is at a conference in Dallas, Texas. Magistrate Lou Endres has retired after 23 years, and they have hired three new probation officers. He thanked Ginger Yonak and Kenzie Fisher for their help in getting these positions filled.
- Judge Fraser had no report.
- Ginger Yonak stated the second EAP Lunch and Learn will take place this Thursday at London Avenue. The topic is "Managing Your Emotions in the Workplace", and lunch will be provided. Registration for that will close today at 4:00 p.m. There were about 50 participants in the Wellness Scavenger Hunt, and she thanked the Wellness Committee for putting that together. The Health and Benefits Fair will be on September 16, from 7:30 a.m. 9:30 a.m. There will be breakfast items, wellness providers, flu shots, yoga and more. The first 100 attendees will get a mum. The deadline to complete the KnowBe4 Cybersecurity Training is Friday, August 15. The County/City Softball game is Saturday, August 23.
- Jessica Cain stated chip seal will be done in the next few weeks. They focused on the northern part
 of the county this year. The Waldo Road Bridge project has started, and the road will be closed for
 a month. The Millcreek logjam project is going well, and the Claibourne Road Bridge Project will
 start next week.
- Cayla Warnock stated Harold Lewis School will now be called Mini Monarch Academy at Harold Lewis.
- Andrea Weaver stated residents will be getting postcards in the mail from the Auditor's Office informing them the tentative 2025 real estate values are on the website. The postcards will also have instructions on how to schedule an informal meeting with an appraiser to talk about values. The final abstract is approved by the state on October 31, and all informal meetings need to be done before that date. The only changes that can be made after October 31 are due to clerical errors. The Auditor's Office has an open appraiser position. The deadline for special assessments to be submitted is the second week of September.
- Mike Justice stated the laser shot went very well at the Union County Fair. Over 250 people participated and it was good to have interactions with local kids. Tonight is National Night Out at the Jerome Township Fire Department.
- Danielle Sullivan stated they have hired a new employee at the Title Department, and she thanked staff for the new windows in the courthouse.
- Karen Riffle had no report.
- Jimmie Inskeep stated the upper level of the parking lot is being sealed today. Tomorrow the lower-level parking lot will be blocked off, and staff will need to find other parking spots until Friday when the project is done.
- Bill Narducci stated there will be 10 Yorii exchange students coming to Marysville later this month. On Monday, August 25, they will be touring the courthouse. There were over 50 applicants for the budget analyst position, and the first round of interviews will be completed later this week. Second round of interviews will be in front of the Board. He thanked Christy Bailey and Amy Wesley in the Auditor's Office for their continued help.

- * Except for Dublin & Washington Twp (Franklin Co) however we do support them in planning and response efforts.








