SCHEDULE OF COURT COSTS AND FILING FEES
FOR MATTERS BEFORE THE JUVENILE DIVISION

The following schedule of costs and required deposits is hereby adopted for the Union County Court of Common Pleas, Juvenile Division and ordered effective **January 28, 2019**.

Court costs are *exclusive of any fines or restitution amounts* that may be ordered, as permitted by law, upon dispositions of juvenile delinquency, unruly and traffic matters, as well as criminal adult matters. Court costs are in part set forth in the Ohio Revised Code, as amended from time to time.

Filing fees shall be tendered as a **deposit** for the payment of court costs by the complainant or movant upon filing to initiate, reactivate or respond to various child custody and child support matters that are within the jurisdiction of the court. *Filing fees are deposits only* toward the court costs that may be incurred during the action, including the total cost of a Guardian ad litem's investigation and report. The Court will apportion the total court costs among or between the parties prior to the conclusion of the matter.

Such actions/pleadings include, but are not limited to: *Complaints to Establish Parental Rights and Responsibilities; Complaints to Establish or Disestablish Parentage/Paternity; Counterclaims to Complaint; Motions to Reallocate Parental Rights and Responsibilities; Motions for Modification of Agreed Visitation/Parenting Time; Motions for Mediation; Motions Contra; Motions to Show Cause; Motions for Relief from Paternity Determination or Support Order; and Registration of Foreign Child Custody and Support Orders. Actions initiated or reactivated by the Child Support Enforcement Agency do not require a deposit from the Agency.*
