- Reviewed County Auditors' Association of Ohio Auditor Budget Issues Am. Sub. HB96
  - Budget Commission items begin on page 3 annually, during one public meeting, the Budget Commission should describe the concept and function of inside millage, how it is allocated to various jurisdictions in the county, and the fiscal impact of inside millage
  - o Inside millage information can be found on the Auditor's website via the T014.02 report
- Upcoming ballot issues:
  - Darby Twp 1.5 mill replacement levy which will reduce the current 1.65 mill levy
  - o Dover Twp 4.5 mill replacement levy which will reduce the current 5.5 mill levy
  - Jerome Twp renewal with 1.0 mill increase from the current 5.8 mill levy
  - Millcreek Twp 4.8 mill renewal
  - Union Twp 5.5 mill replacement levy with an increase
  - Washington Twp 1.8 mill renewal levy
  - Union County Bd of DD 3.8 mill renewal levy
  - Magnetic Springs 5 mill renewal levy that has passed and is effective 2025
  - Richwood 1.2 mill renewal levy that has passed and is effective 2025
- Fire Departments should consider combining because of the shortage of employees who are seeking larger entities for higher paying positions
- Andrew Smarra, Treasurer, would like a breakdown of the County's 'other sources' for the special revenue funds
- The Budget Commission shall send letters, to both the Union County Airport and the City of Marysville, requesting the following:
  - O Union County Airport if budgeting for a multi-year grant, the current year budget should include a percentage, ie. 1/3 for a three year grant, not the entire grant amount. Because of the uncertainty of the revenue, only include monies that are approved via a grant and/or assured resource. Amend the revenue budget throughout the year, as applied-for grants are awarded.

o City of Marysville – submit budget documents to the Budget Commission on a timely basis.
