This addendum supplements and amends the original Drawings and Specification issued and shall be taken into account in preparing proposals, and shall become a part of the Contract Documents.

1. Drilled shafts shall be used for foundations.
2. Approach slabs shall be constructed per AS-1-15. Sleeper slab shown in AS-2-15 is not required.
3. Aggregate drains shall be constructed per ODOT standards.
4. Utility poles will be relocated prior to construction.
5. Bid reference #31 for the SWPPP may be non-performed if it is determined by EDA that a SWPPP is not necessary.
6. Substructure recommendation was not provided by CTL when they performed test borings.
7. The low point of the superstructure shall be no lower than 1000.1.
8. A DBE checklist is attached for the convenience of the bidders.
