Swan Esq. President and Robert
Nelson Amos A Williams and John
Porter - his associates at a court of
Common Pleas Begun and Held
at the Court House in the town of

Marysville County of Union and State of Ohio on the 25th Day
of August AD 1834 This Day an authenticated copy of the last
will and testament of Thomas M Baily late of Accomack
County in the State of Virginia Being produced in open Court
and it appearing that the same had been duly proved in said
County agreeably to the laws of said State and that the same
relates to Land in the County of Union and State of Ohio Do
Order that the same be admitted to record in this court and duly
certified - which said last will and Testament Reads in the
words and figures following to wit

I Thomas M Baily of Accomack County State of Virg-
inia attorney at Law do make and ordain this my last will
& Testament in manner and form following
First I Give bequeath and Devise to my Beloved and affect
ionate wife Jane O Baily every sort of personal Estate whatsoever
which Belonged to Her at the time of our Marriage and
which remains in my possession at the time of my Death in
slaves not only the Slaves But the children of the Slaves & also

including not only the Slaves But the Children of the female Slave
which Belonged to Her and have been bound since our Marriage
to Her and Her heirs and Assigns forever

Secondly I Give & Bequeath unto My beloved wife Jane
Bailey During her Natural life and widow hood the following
Slaves & their increase (By) the children born of the female Israel
Dinah and Her Children Eley and the Children of Mariah
By Sukey Richard William Nathaniel Henry & John and at the
Death ~~and~~ or Marriage of My wife I Give and Bequeath them and
their increase to My Daughter Jane Bailey to Her and Her Heirs
forever and assigns forever

Thirdly I Give unto My beloved wife to Her and Heirs forever
the plantations called the Vale of Scarborough Neck and which
formerly belonged to Her father The above property Real and
Personal is bequeathed Given & Devised unto My Beloved wife
upon this express Condition that she to pay and exonerate
My Estate from a Debt due unto Robert Hadlock By me a
Bond given for the purchase of the Said plantations But I di-
rect that the Money due ~~and~~ ^{on} the exonerations of Lands of
Samuel Cowards estate shall be applied to the payment of the
Debt to Robert Hadlock

Fourthly All that tract of Land called Mount Custis which
includes the plantation on which I live and the plantation on
which James Chandler lives and all the Horses and live stock
of every kind and all the farming implements of all sorts I
Direct shall Remain on it for the term of live years To wit

from the first day of January after my Death and the said farm to be cultivated and the profits and proceeds thereof to be applied to the support of and education and Maintenance of Thomas H Bailey A D Bailey Sally Bayly Elizabeth H Daily and Margaret P Bailely the profits of Mount Curtis tract on which I Reside to be applied to the Educating & Maintaining of my five Children aforesaid for five years but tract on which James Chandler Resides the profits for five years to go to payment of my Debts

Fiftly the plantation called Marino & the Mill and the Mill Lot and House and all the horses Mules & Stock and farming utensils of every kind and all the stills still tubs casks stand tubs barrels hogsheads and every thing else relating to the Making of a Crop of brandy or Grain I Direct shall remain and be carried on as it now is for five years to commence from the first Day of January after my Decease and the proceeds to go towards the payment of my Debts.

Sixthly At the end of five years from the first Day of January after my Death I Give and Devise to my Son Thomas H Bailely the whole of my Mt Curtis plantation Being the Land on which I Now Live and the Land on which James Chandler lives to him and his assigns upon this express condition that he shall sell in the whole or in part or parcel with instalments of five years but all the instalments to carry Interest from the Day of Sale provided he can obtain for the said Land sixteen thousand Dollars the proceeds of Sale is to be equally divided Between my four Daughters viz Anna Sally Elizabeth and Margaret but should my Son Thomas not

Anna Sally Elizabeth and Margaret but should my son Thomas not be able to sell my said plantation then I Give and Devise it Equally to be Divided between my said four Daughters equally share and share alike to them and their Heirs and assigns forever

Seventhly After the expiration of five years from the first Day of January after my Death Give and Devise to my Beloved wife Jane O Bayly During her Natural Life or Widowhood My plantation Called Marino the Mill & Mill tenement attached therunto all the Still casts and all articles and utensils on it for the Making of Brandy or Grain and all the horses Mules and live stock on it and at her Death or Marriage I Give and Devise the said plantation Mill and Mill Lot and the personal estate above mentioned in the clause to my Daughter Jane O Bayly to her and her Heirs and assigns forever

Eighthly I Give and Devise to my son Thomas A Bayly his heirs and assigns forever ten thousand acres of my Ohio Land his choice excepting my houses and in lots in Chillicothe But upon this express condition That he comply with my wishes and Directions as to the Sale and conveyance of my Mount Custis Tract of Land But should he refuse or Neglect to comply with my Directions as to my Mount Custis Lands then I Give and Devise my Mount Custis lands equally to my four Daughters of^d Ann Sally Elizabeth & Margaret Bayly and I Give and Devise my ten thousand acres of Lands of^d in Ohio the first choice to my Beloved wife During her Life and then to my Daughter Jane to her and her Heirs forever but should my wife Mary then in that case the said Tract of ten thousand acres of Land w^o go immediately to my Daughter Jane & I do further Direct & Declare that should my son Thomas should not comply

with my Directions afo^r as to my Mt Custis Land there he forfeits
 all the estate Real and personal given to him here before or hereafter
 in this will and the Estate so given to him to be given I do hereby de-
 vise and give the same to my daughter Jane Bagly and her heirs
 forever. Ninthly I give and bequeath to my Son Thomas my Law
 Books of every kind my other books in my Library Maps and charts
 I Give equally to be divided between my wife and five daughters
 Tenthly All my slaves not given to my wife I Direct shall remain
 with my executors to carry on the crop for five years afo^r But should
 any of them misbehave or act unproperly I do authorise and empower
 my executrix and Executor to make Sale of such as do misbehave and
 at the end of five Years I Give and bequeath the said Slaves and their
 increase to equally divided between my son Thomas and my five
 Daughters.


Eleventhly for the purpose of Raising a fund for the payments of my
 Debts I Direct my executrix and executors to sell ^{any of} ~~the~~ my personal
 Estate which is wasting and not useful in the family which they may
 think best for the interest of Estate should be sold except what my wife & slave
 I also direct that all my Spare Cops shall be sold except what my
 wife thinks is necessary for the family's Support. I also Direct
 and empower my executrix executor to make Sale upon such terms
 as my executrix see proper And at such times as she thinks best my
 Lot in Drummond Town my Land on Guilford called Fishers
 my Land on Wallots Road called Pomeroy and all my

not Given & Devised in this will all my houses and Lots in Chillico-
the all the Remainders of my Lands in Ohio except the ten thousand
Acres devised before and my tract of Land in the State of Illinois-
Twelfth The Boy William P Bayly I Direct shall have no part or parcel
of my estate but that he shall be kept to an english School at the expen-
se of my estate until he is twelve years of Age and bound out by my
son Thomas to a Mechanical or Manufacturing trade in the State
of Massachusetts

Thirteenth Give to my wife all my pictures and such other furn-
-iture at my wife House at Mount Custis as she wishes to take for the
use of the family

Fourteenth I Appoint my wife Guardian to my son Thomas and five
Daughters

Sixteenth I Do nominate my and appoint my beloved wife Jane
O Bayly and my son Thomas M. Bayly executrix and executor
of my to this my Last will and Testament & I Direct that they shall
give no Bond for the executorship nor make any appointment without

I Miles Selden of the county of Prince George
do make and ordain this my last will and Testament.

Imprimis, I give to my Executors hereafter to be named full
power and authority, for the purpose of discharging all my just
debts, from time to time, to make sale of such parts of my
estate, real or personal, and in such manner as they shall
consider ^{most} conducive to its interest.

I am I wish and desire that my estate shall be kept together
and cultivated for the benefit and support of my children, until
my first son shall reach the age of twenty one years, or either
of my daughters be married; in either case I wish an equal
portion of my estate to be assigned them, and when my second son
shall arrive to the like age, or a daughter married, that he or
she in like manner receive his or her ^{equal} portion, and so on till the
whole is disposed off, which portions when so assigned, I give to
them and each of them, their heirs and assigns forever.

3dly It is my will and desire that my mother take charge of
my children, and that she should reside on my estate, if agreeable
to her, from which I desire that she shall be supported, and
in addition I give to her the commissions to which I am entitled
as the executor of my father's estate.

4th I desire that no appraisement of my estate be made.
Lastly, I constitute and appoint my brother Williams Selden
my friend John Edloe, and Thomas Coker executors of this
my will and request no security may be required of them on
their qualification as executors. In Testimony I have





