Did you know?

Union County Senior Services is primarily funded by the Union County Sales and Use Tax Levy. Union County Senior Services and the Union County Engineer's Office share the sales and use tax as follows: "sales and use tax in the amount of one-quarter of one percent for the purpose of generating revenues to benefit the general fund to be allocated and split 50% for the improvement, construction, reconstructions, maintenance and repair of Union County roads and bridges and 50% for direct senior services including home delivered meals, home health care, transportation,

and other senior services for a period of 5 years." The Sales and Use Tax Levy is on the ballot every five years. **The next ballot will be on November 8, 2022**. Jessica Cain from the Union County Engineer's Office and Janell Alexander from Union County Senior Services attended training provided by the Central Ohio Public Information Network on techniques to communicate to the public the financial stewardship and plan for these public funds.

Did you know?

Union County is unique in that every person (even non-residents and non-property owners) that makes a purchase in Union County contributes to the services that Union County Senior Services provides and the roads and bridges that the Union County Engineer services. For example, if a person purchases \$100 at a

local store, \$0.12 will go to Union County Senior Services to provide home delivered meals, home health care, transportation, and other senior services.

Did you know?

Financial Stewardship: Union County Senior Services is following the levy language as the guide for assisting Union County Seniors to live safely and independently in the community. In 2022 Union County Senior Services focused on increasing services to reach and exceed pre-pandemic levels, to ensure the levy funds and COVID grants are being spent timely. For example, the budgets for home delivered meals increased by 40% and the home health care was increased by 79%. For transportation, two new providers were added, in addition to UCATS, to increase transportation options for Union County Seniors to include trips on evenings and weekends. Union


County Senior Services also expanded the types of trips to include activities of daily living.

Plan: Over the next five years, Union County Senior Services will continue to follow the levy language and serve as many Union County Seniors as possible to keep Seniors living safely and independently in the community. We will leverage the levy funds and grants to extend the levy services like meals, home health care, and transportation.

Transportation for Seniors

For calendar year 2022, Senior Services wants to ensure Union County residents 60 years of age or more are getting their transportation needs met to the best of our ability with available resources. UCATS and Legends Lift & Transport are contracted to transport seniors to their activities of daily living (medical, shopping, banking, legal, exercise, library, miscellaneous civic needs, etc.) and activities of socialization free of charge to the senior. The only eligibility criteria is to be 60 years of age or older and a resident of Union County. There is no cost for the riders. Below is the contact information for transportation.
