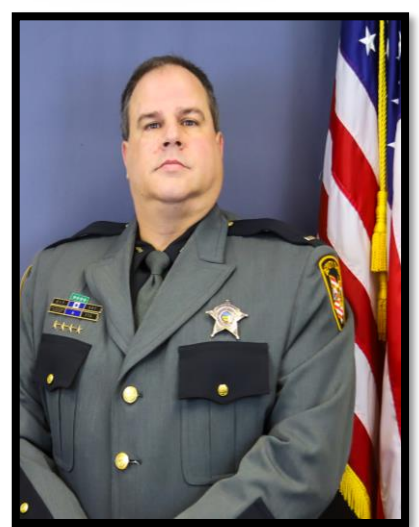

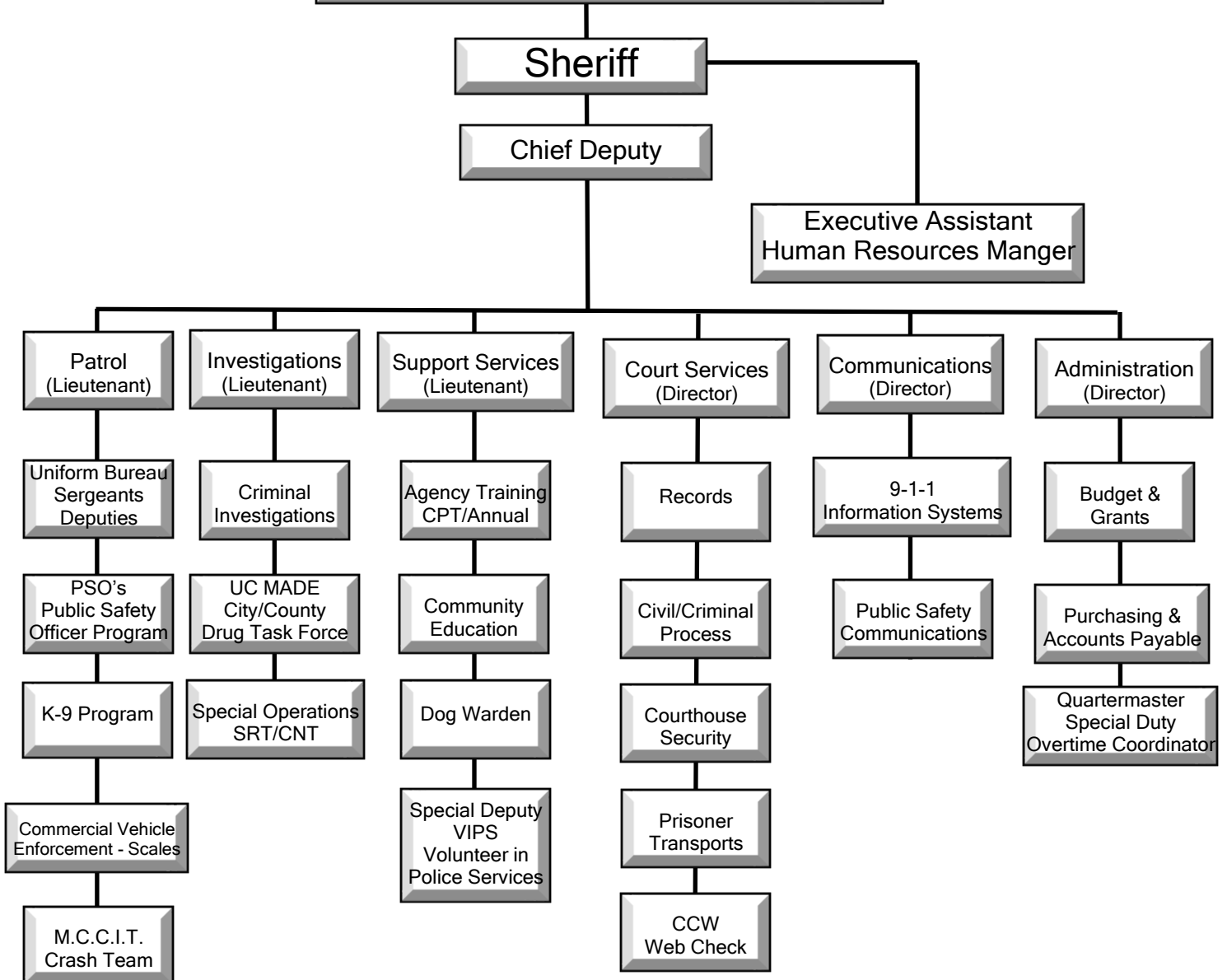

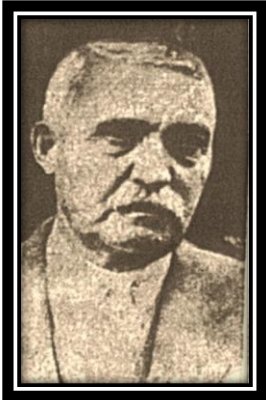
# ORGANIZATIONAL CHART

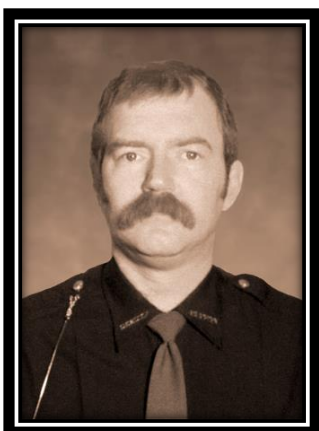
### SHERIFF F.S. HAGER

On September 23, 1927, Sheriff Forest S. Hager had been at his farm in Washington Township and later traveled to Richwood in his Ford Sedan to serve several papers. On his return from Richwood, Sheriff Hager was struck by an eastbound passenger train at the Erie Railroad at Beaver's Crossing. Sheriff Hager was preceded in death by his wife Claudia Stamates. At the time of the accident he was survived by two daughters, Mrs. Frank Hager, Marysville and Mrs. James Hanby, Richwood and a son H.B. Hager of West Mansfield.



### SHERIFF HARRY L. WOLFE

Sheriff Harry L. Wolfe responded to a burglar alarm at a home on Robinson Road that sounded at the Union County Sheriff's Office on January 21, 1982. Sheriff Wolfe radioed the Union County Sheriff's Office an officer-in-trouble alert. Another Union County Deputy, responding to the scene, found on his arrival, the Sheriff lying beside the right front wheel of his cruiser. Sheriff Wolfe, age 59, had been elected for a second term of office in January 1982. He was retired from the Ohio State Highway Patrol and was active in many community organizations. Sheriff Wolfe was survived by his wife Paula, and sons Lee and Steve, along with daughters, Kim and Karen.



### SERGEANT ROGER L. BEEKMAN

Sergeant Roger L. Beekman was responding to a burglar alarm with lights and siren on September 19, 1979. Sergeant Beekman was westbound on Industrial Parkway at the time of the crash when he apparently entered the intersection of Industrial Parkway and US 42 and was struck by a northbound semi. Sergeant Beekman, age 29 years, had joined the Union County Sheriff's Office as an auxiliary deputy in August 1977. He was hired to full-time status in April 1978 and served as a plain clothes detective for nearly five months. He had requested road deputy duties, because he said that was where his heart was. Sergeant Beekman was survived by his wife, Karen and two daughters, Amy and Angela.

## *History of the Sheriff*

*The Office of Sheriff is one of antiquity. It is the oldest law enforcement office known within the common-law system and it has always been accorded great dignity and high trust. For the most part, the Office of Sheriff evolved of necessity. Were it not for laws which require enforcing, there would have been no necessity for the Sheriff. There would have been no need for the development of police administration, criminology, criminalists, etc. This is not the case, however. Man learned quite early that all is not orderly in the universe. All times and all places have generated those who covet the property of their neighbors and who are willing to expropriate this property by any means. As such, man's quest for equity and order gave birth to the Office of Sheriff, the history of which begins in the Old Testament and continues through the annals of Judeo-Christian tradition. Indeed, there is no honorable law enforcement authority in Anglo-American law as ancient as that of the County Sheriff. And today, as in the past, the County Sheriff is a peace officer entrusted with the maintenance of law and order and the preservation of domestic tranquility.*

*Sheriffs have served and protected the English-speaking peoples for a thousand years. The Office of Sheriff and the law enforcement, judicial, and correctional functions he performs are more than 1000 years old. The Office of Sheriff dates back at least to the reign of Alfred the Great of England, and some scholars even argue that the Office of Sheriff was first created during the Roman occupation of England.*

*Around 500 AD, Germanic tribes from Europe (called the Anglo-Saxons) began an invasion of Celtic England which eventually led over the centuries to the consolidation of Anglo-Saxon England as a unified kingdom under Alfred the Great, late in the 9th Century. Alfred divided England into geographic units called "shires", or counties.*

*In 1066, William the Conqueror defeated the Anglo-Saxons and instituted his own Norman government in England. Both under the Anglo-Saxons and under the Normans, the King of England appointed a representative called a "reeve" to act on behalf of the king in each shire or county. The "shire reeve" or King's representative in each county became the "Sheriff" as the English language changed over the years. The shire reeve, or Sheriff, was the chief law enforcement officer of each county in the year 1000 AD. He still has the same function in Ohio in the year 2000 AD.*

*The concepts of "county" and "Sheriff" were essentially the same as they had been during the previous 900 years of English legal history. Because of the English heritage of the American colonies, the new United States adopted the English law and legal institutions as its owner.*

*Clearly, the Sheriff is the only viable officer remaining of the ancient offices and his contemporary responsibility as conservator of the peace has been influenced greatly by modern society. As the crossbow gave way to the primitive flintlock, the Sheriff is not unaccustomed to change. But now, perhaps more than ever before in history, law enforcement is faced with complex, moving, rapid changes in methodology, technology, and social attitudes. As Thomas Jefferson wrote in his *THE VALUE OF CONSTITUTIONS*, "the Office of Sheriff is the most important of all the executive offices of the county."*

*The office of Sheriff is certainly significant and was in fact the first county office established in the United States. Some very outstanding Americans have held the office of County Sheriff from the earliest days down to our present era. George Washington's father was an early Sheriff in Colonial Virginia. The history of the position and functions of a Sheriff, prior to establishment of the position in America, can reportedly be traced to provisions of the Magna Carta in England, in the year 1215.*

The Union County Sheriff's Office Court Services Division is responsible for maintaining security at the Justice Center, Common Pleas Court and the Juvenile/Probate Court. In addition, they are responsible for transporting prisoners and juvenile detainees to and from the appropriate detention facilities as well as court hearings. The Civil Process Clerk processes all court paperwork including civil papers and warrants for service by the Patrol Division; with assistance from Court Service Deputies; handles all aspects of Sheriff Sales and property executions; coordinates transports with Court Service Deputies; enters and maintains files for citations and friendly warnings. The Records Clerk is responsible for all background checks including Web Check requests for the public and insurance companies for copies of accident and incident reports; handles all requests for statistics for officers, outside agencies and the general public. The Court Services Division is also responsible for registering Sex Offenders within the county, civilian fingerprinting and handling Conceal Carry registrations.

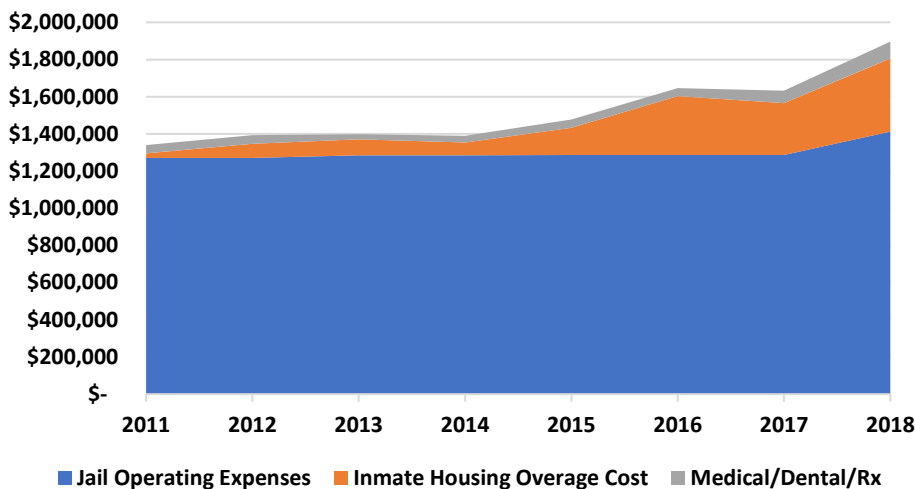

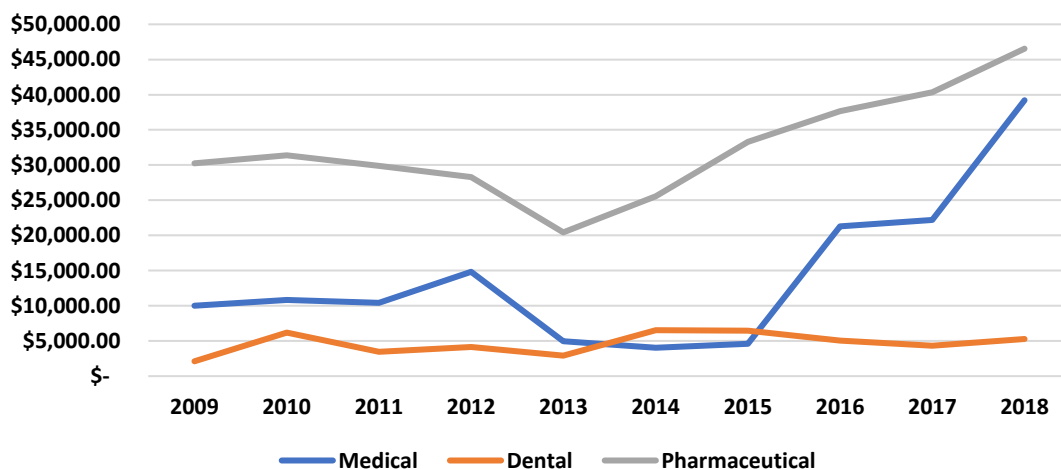

The Tri-County Regional Jail serves and protects the citizens of Champaign, Madison and Union Counties. The cost of housing and caring for inmates has steadily increased since 2011 while Jail operating costs have remained relatively stable. In 2018, an increase in operating expenses was necessary to carry out the essential functions of supervising and caring for inmates.

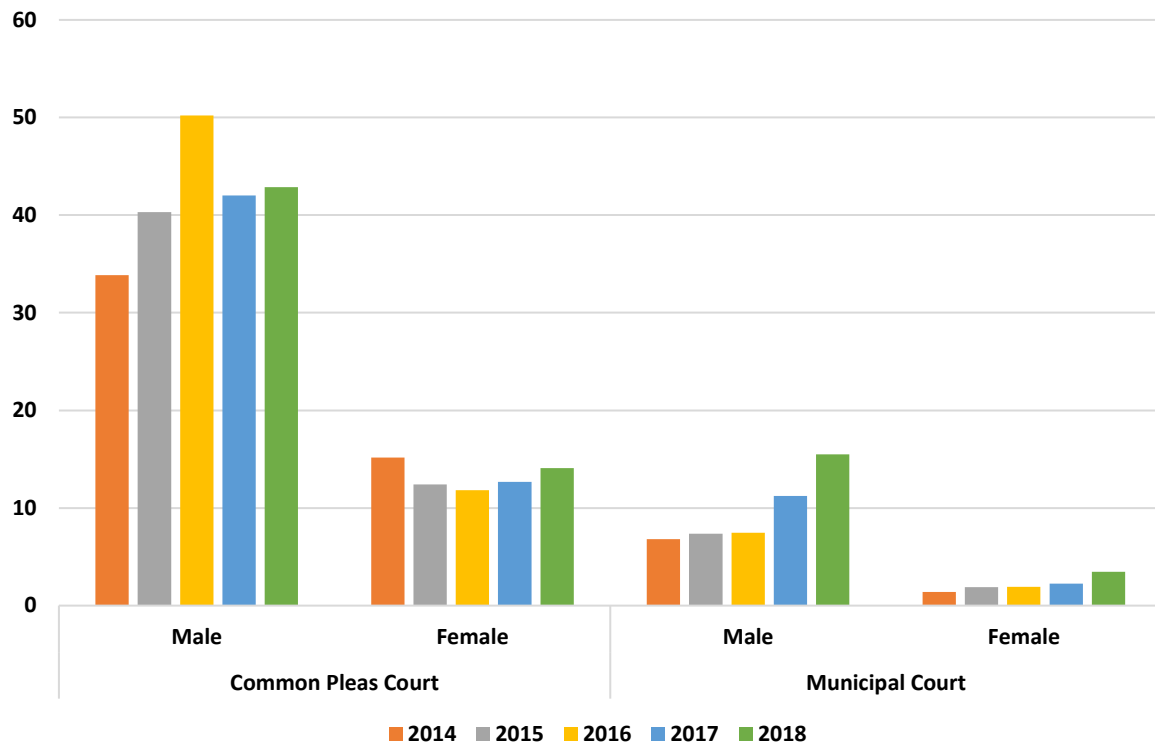


In general, inmate healthcare costs continue to rise with prescription medication making up the greatest part of this expense.

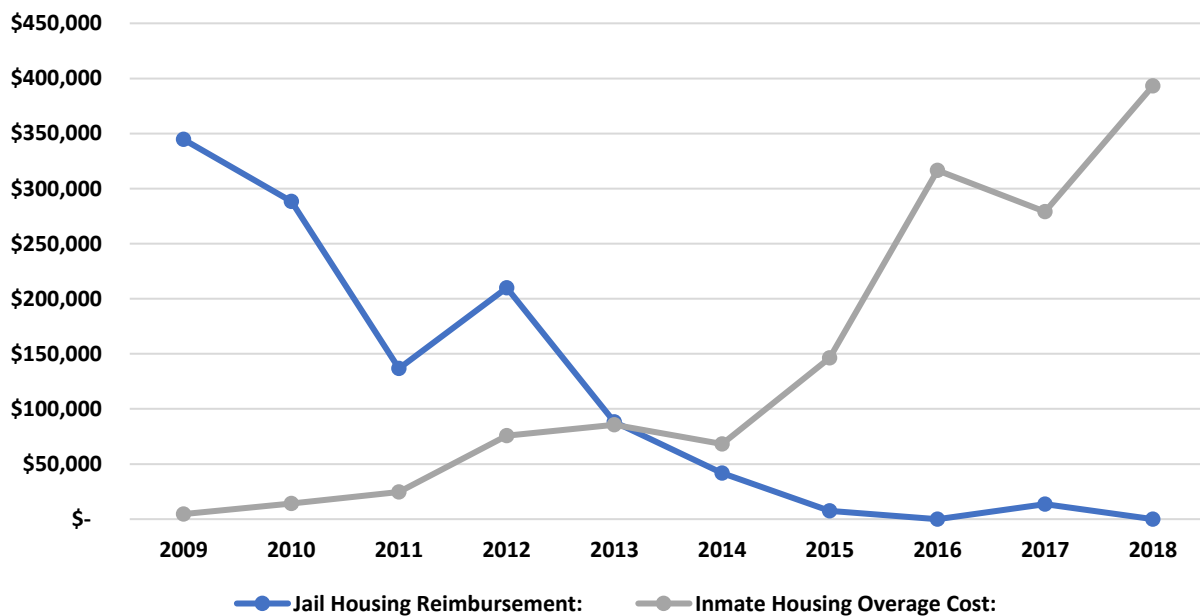


Union County has an allowance of 52 inmate beds at the jail. In general, there has been an increase in inmate population - both male and female - over the last five years.

As the inmate population grows, so does the cost of care and housing. After a slight decrease in housing overage cost in 2017, the upward trend continued in 2018.



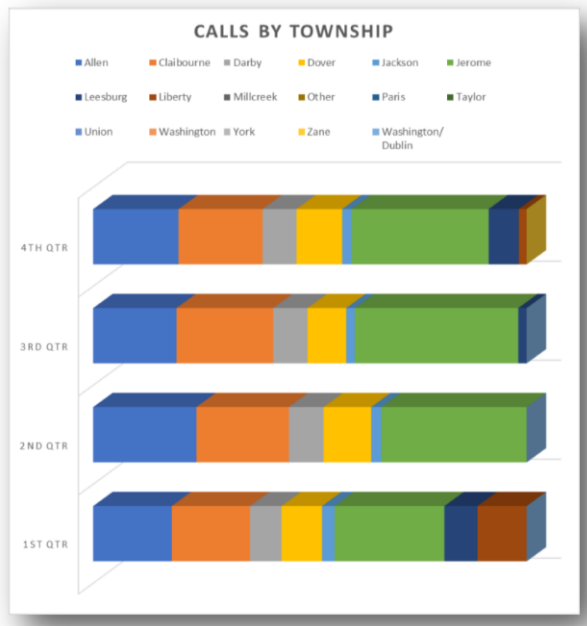

The Union County Sheriff's Office Communications Division is responsible for receiving and dispatching calls for service (including 9-1-1 calls), as well as dispatching for nine (9) Fire and EMS Departments and two (2) law enforcement agencies in addition to the Sheriff's Office. The dispatchers on duty must monitor ten (10) phone lines (which include 7, 9-1-1 lines), four (4) radio frequencies, TDD, two (2) alarm central station receivers, LEADS computer, airport monitor, weather and tornado sirens, warrant computers and greet the public.

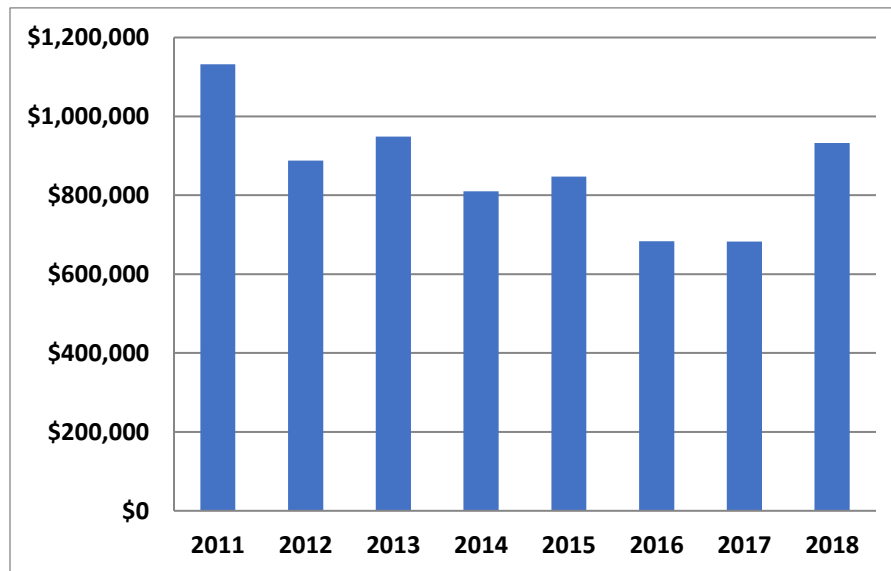

The Administrative Division is responsible for providing administrative support on a daily basis with numerous tasks, including but not limited to, human resource functions such as file maintenance, personnel administration, employee benefits and background investigations; financial functions such as accurate reporting, budgeting, inventory, grant research and funding; accounts payable functions, such as purchasing and processing purchase orders, payroll and the quartermaster system; accounts receivable functions, such as invoicing, receipt recording and processing pay-ins; research and development; legal matters; policy and procedures; contract negotiations and labor management.

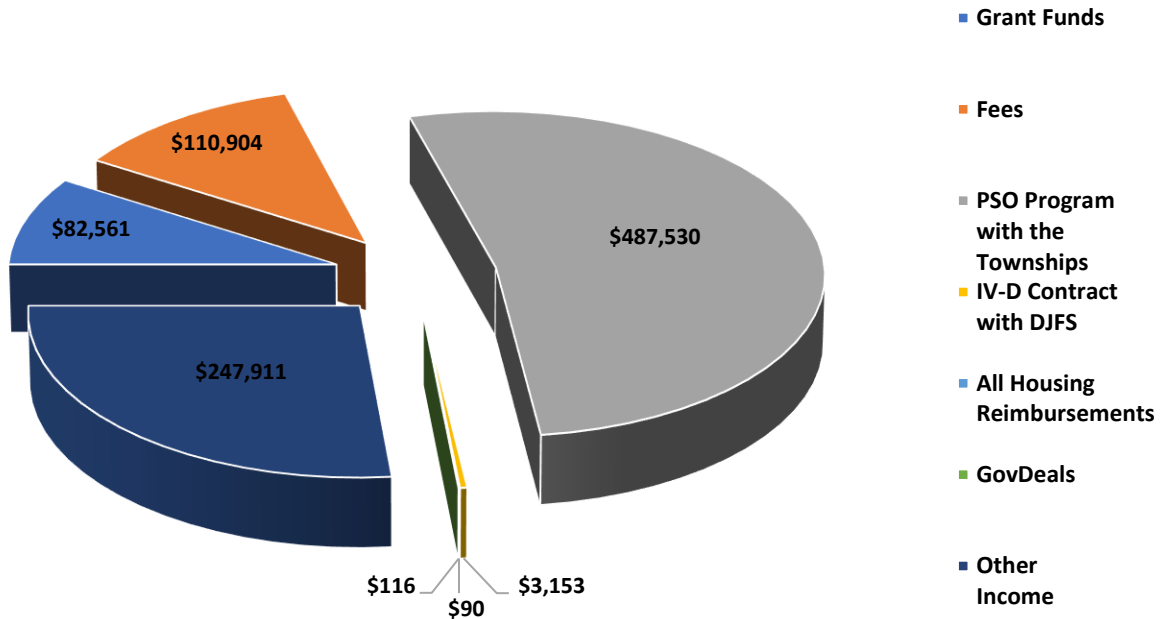
The graph below shows revenue into the General Fund by the Sheriff's Office over an eight-year period.

This chart illustrates the sources of general fund revenue in fiscal year 2018.

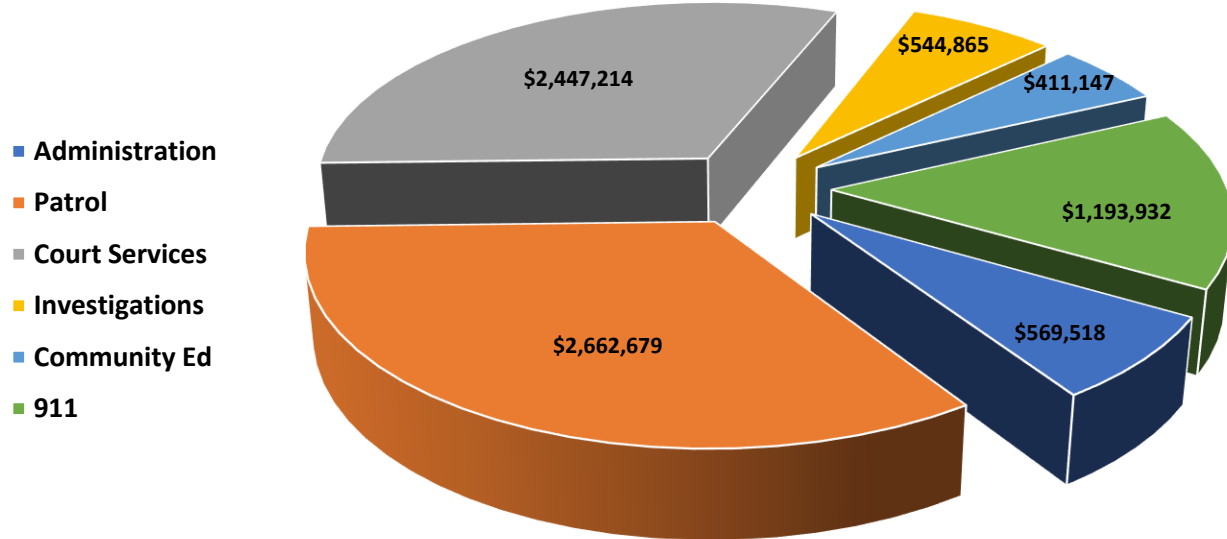

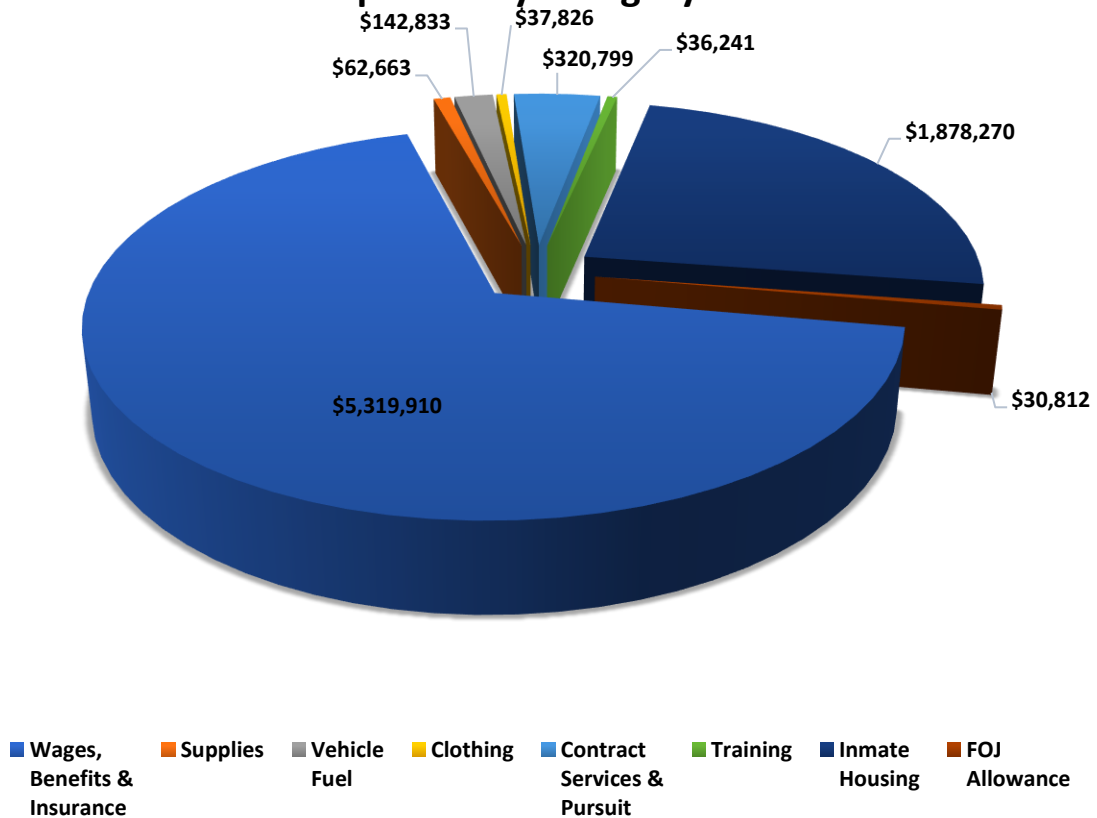
- Grant funding, in general, is becoming more difficult to obtain. The amount listed here was used to subsidize the wages of two School Resource Officers who instructed students in the Fairbanks and North Union School Districts in the DARE program.
- The fees category includes receipts from Sheriff's Sales, cruiser fees from special duties, fees from paper service and fees from copies of reports.
- Townships participating in the PSO program are: Allen, Darby, Jerome, Liberty, Millcreek, Paris and Taylor.
- Service of process trips made by Sheriff's Office deputies under the IV-D contract with DJFS for child support delinquency totaled 58.
- Housing reimbursements include payments for DUI Housing from Marysville Municipal Court as well as inmate housing overage reimbursements and inmate Pay for Stay at Tri County Regional Jail.
- The Other Income section includes restitution, unexpended FOJ funds, the Sheriff's salary reimbursement from the State of Ohio and salary reimbursements for the positions of Dog Warden, School Resource Officer and DJFS Detective.
- Managed the Sheriff's Office budget of \$9,525,762 million which includes expenses from Tri-County Regional Jail and the 9-1-1 Center
- Received \$487,530 from Public Safety Officer and \$101,329 from School Resource Officer contractual relationships with participating townships, villages and the school districts of Fairbanks and North Union.
- Collected \$98,477 in fees for all Sheriff's Office services

- Received \$18,233 in donations for the Sheriff's Office Community Education programs by hosting events like the Safe Heroes Golf Outing and the Turkey Shoot
- Received \$83,875 in funding from the Ohio Attorney General's Office in support of DARE programs in the Fairbanks and North Union School Districts.
- Collected \$4,450 from other law enforcement agencies for use of our training facility
- Received grant funding for the purchase and installation of two in-car video camera systems as well as a portable radio, battery and charger
- Coordinated the purchase of eight new vehicles in the fleet rotation which included five sport utility vehicles for the Patrol division, one unmarked sport utility vehicle for the Administrative division, one unmarked sport utility vehicle for the Investigative division and a prisoner transport van
- Shared in funding with the Commissioner's Office to replace ballistic vests for three deputies and with purchasing six vests for newly hired deputies
- Assisted with the purchase of seventeen body cameras for the Patrol division. These devices are fully compatible with the in-car video camera systems already in use in all Patrol vehicles
- Replaced fourteen PC's and five laptop computers
- Coordinated the purchase of a new server and desktop computer for processing, editing and storing video from body worn cameras, in-car video camera systems and drone video
- Purchased six portable radios, three mobile radios, five TASERS, five AED's and three in-car video camera systems to replace older models that have reached the end of their serviceable life
- Replaced fourteen rifles for use in the Patrol division cruisers
- Replaced all recording and audio-visual equipment in the interview rooms at South Main Street and the Justice Center

## 2018 Total Expenses by Division

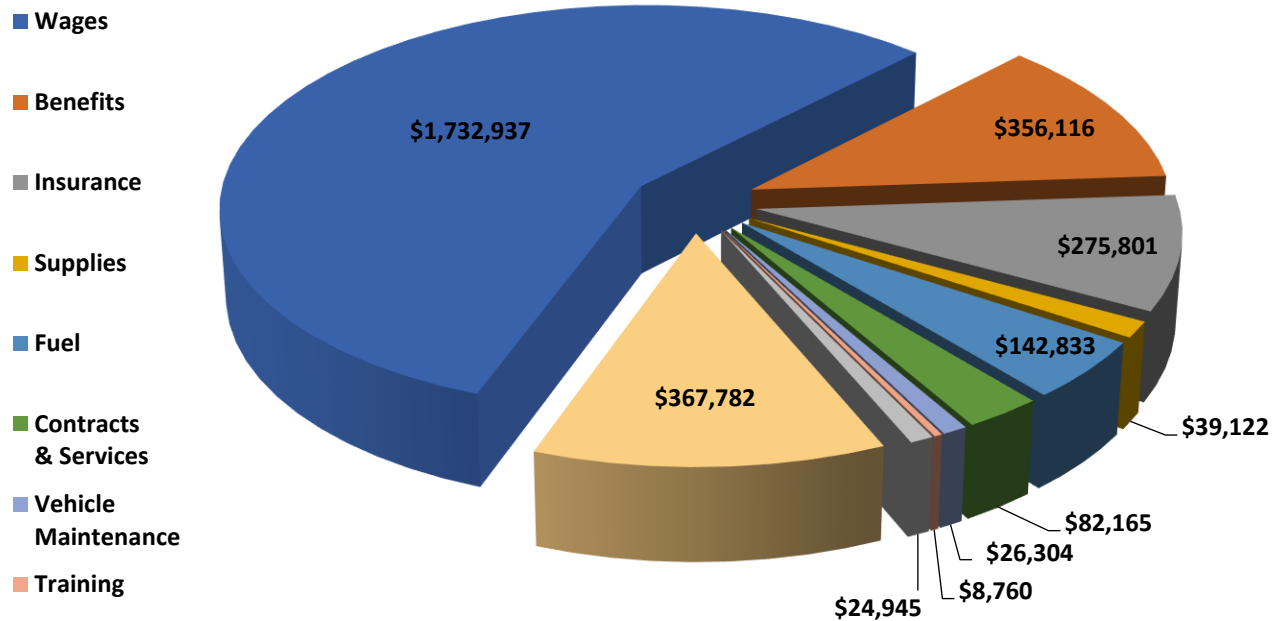


## 2018 Total Expenses by Category - All Divisions

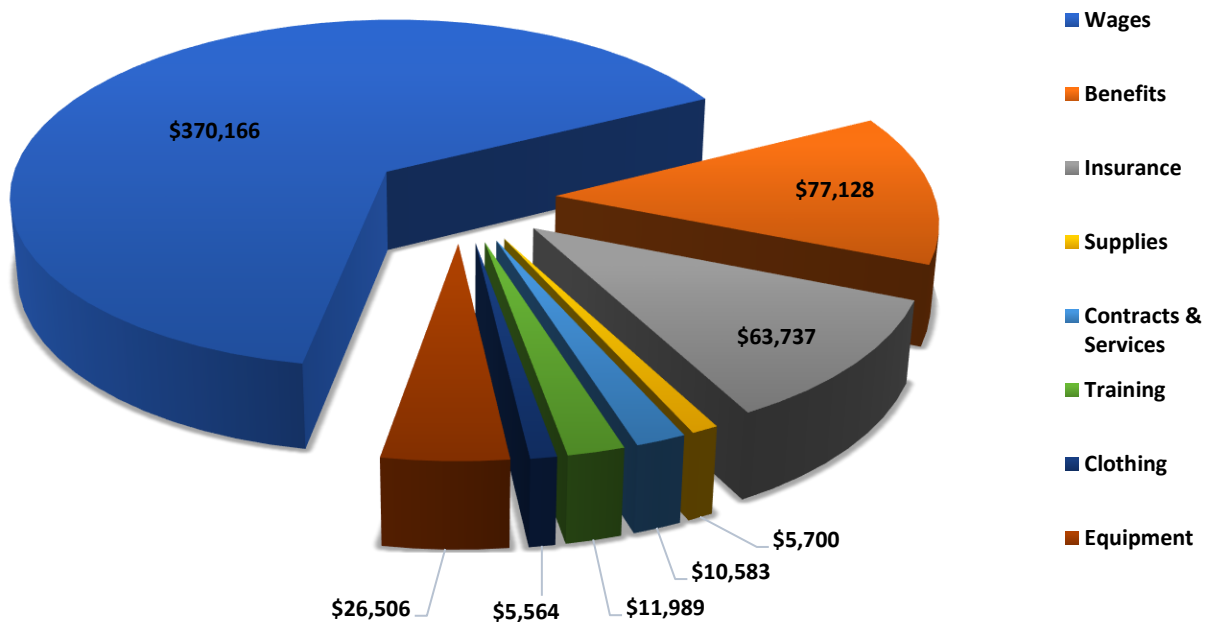


## 2018 Expenditures by Division and Category

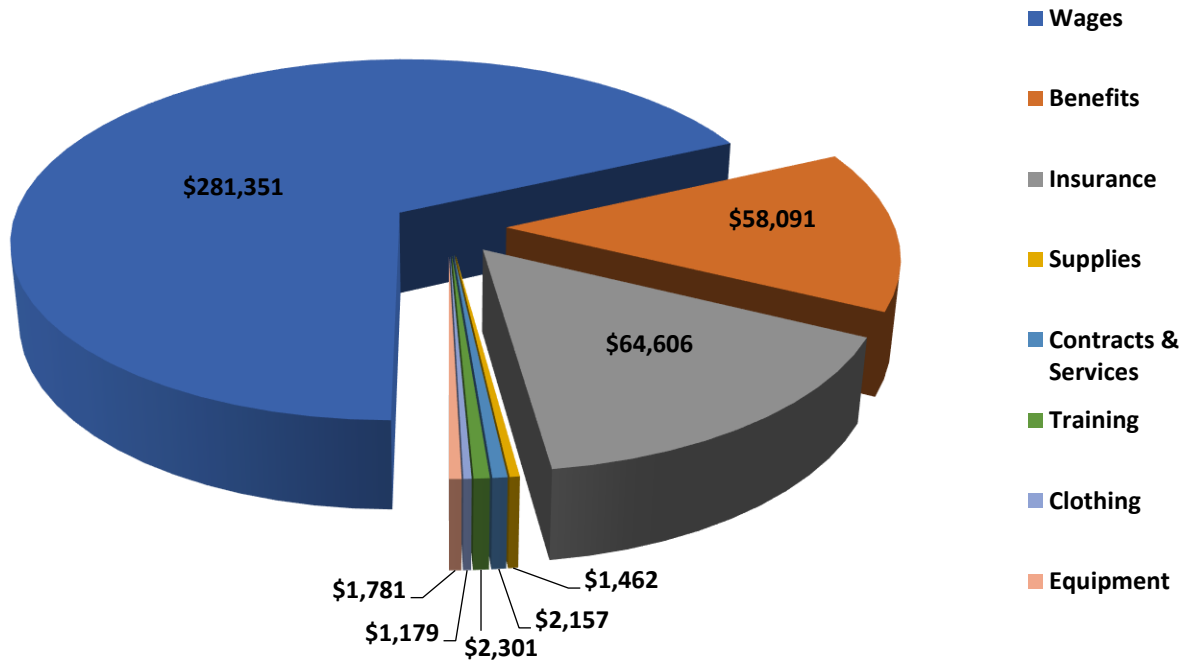

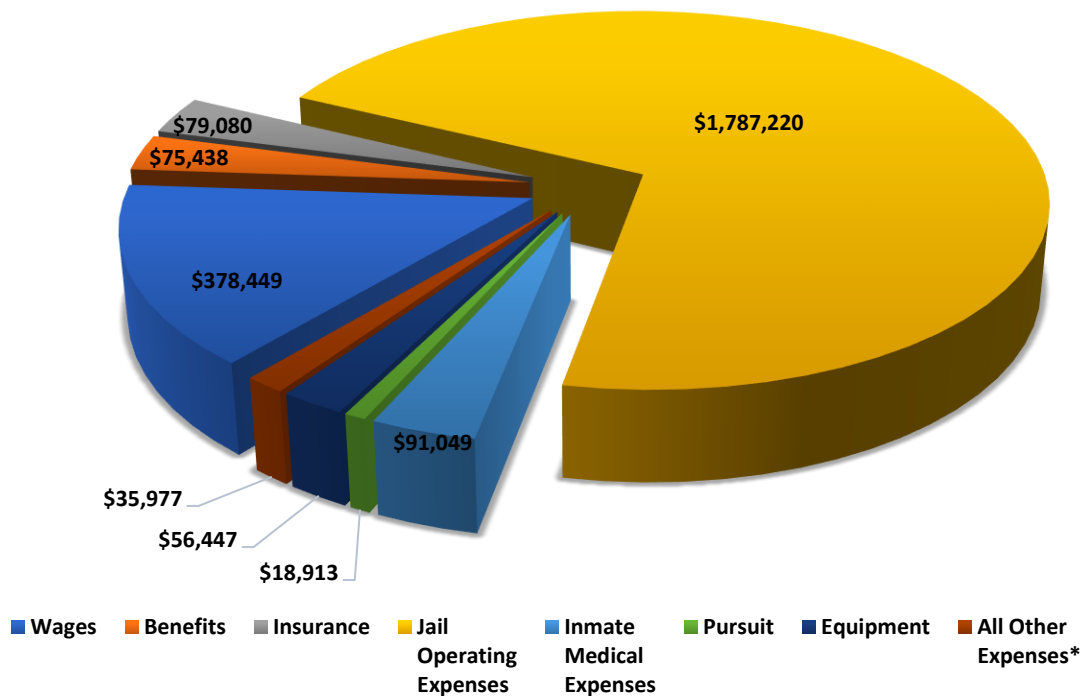

## GENERAL FUND EQUIPMENT

The graph below shows General Fund equipment purchases made by the Sheriff's Office over a seven-year period.



- Every year vehicles are replaced as part of our planned rotation. In 2018, seven Ford sport utility police interceptor vehicles were purchased as well as a Ford Transit van to replace the current prisoner transport van
- Equipment for new Patrol cruisers continues to remain high due to the inability to reuse equipment from retired vehicles in the new models
- Body worn cameras compatible with the in-car camera systems in use in all Patrol vehicles were purchased and put into service
- The audio and visual recording equipment in the interview rooms at South Main Street and the Justice Center was replaced
- Fourteen desktop computers with Windows 7 which will be at end of support in January 2020 were replaced
- A server and desktop computer were purchased to process, edit and store video from body worn and in-car camera systems
- Rifles, radios, in-car camera systems, TASERS and AED's were purchased to replace equipment that is at the end of serviceable life

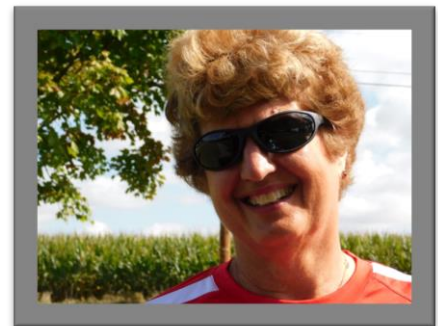
## 2018 VOLUNTEER & POLICING AWARD

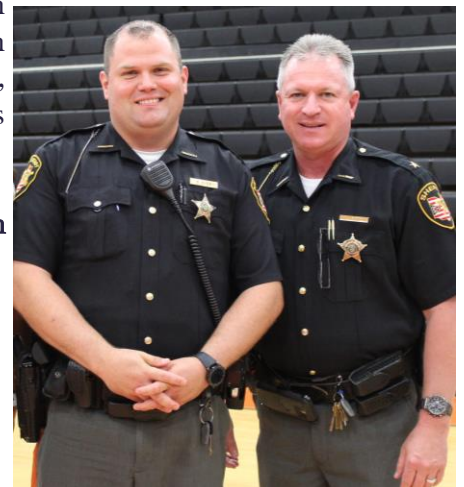

Union County, Ohio – The Union County Sheriff's Office has a new iPhone and Android mobile app which will provide the public direct

alerts of police activity, road closures, motor vehicle accidents and more. The app was released, January 7, 2019 and is now available to download for FREE. Tips can be sent by calling or emailing; the exact location can be sent if the location settings are turned on by the users. Users can send pictures with their tip, no worries this information is confidential unless the user wishes to provide their contact information. "Any actual emergency should still be reported via 911", said Sheriff Patton.

Where Am I? allows users to share their location with others, if they are lost! Other important features include Join Our Team, Sheriff Sales and Conceal Carry information.

"We have created this new mobile app as a service to our county", said Sheriff Patton.
