3/15/2024	12:02	Property Damage Crash	Deputies responded to the intersection of US Route 42 and Crottinger Road to investigate a property damage crash involving a 2010 International Farm Tractor that was struck by a 2017 Toyota Tacoma. The driver of the Toyota, Paul L. Clements, age 76 of Ostrander, was issued a traffic citation for driving left of center while overtaking and passing. A crash report was taken, #80-24-132.
3/15/2024	13:58	Assault	Deputies and units from the Union Township Fire Department and the Pleasant Valley Fire District responded to a field near the intersection of State Route 161 and State Route 38 for a person that was assaulted and thrown out of a vehicle. The victim was transported to Riverside Methodist Hospital and a report was taken, #24-0180.
3/15/2024	15:03	Recovered Property	A deputy took possession of a cell phone that was found in a vehicle parked at the Union County Courthouse. A report was taken, #24-0183.
3/15/2024	18:01	Assist Other Agency / Vehicle Pursuit	Deputies assisted the Marysville Police Department in searching for a vehicle involved with a theft in progress from a business on West Fifth Street. The suspect vehicle was located on US Route 33 near Beecher Gamble Road and refused to stop. A pursuit was initiated, and the vehicle eventually stopped in a parking lot in the 6800 block of Bobcat Way in Dublin. One

			of the suspects fled on foot but was eventually captured. Officers from the Plain City Police Department and the Dublin Police Department assisted with the pursuit. As a result of the investigation, the driver of the vehicle, Eddie C. Bevins, age 38 of Columbus, was arrested for failure to comply with the order or signal of a police officer and obstructing official business. A passenger in the vehicle, Dana M. McLaughlin, age 47 of Columbus, was arrested for obstructing official business. A third suspect in the vehicle was released to the custody of a Marysville Police Officer. Bevins and McLaughlin were transported to
			the Tri-County Regional Jail and two reports were taken, #24-0181 and #24-0182.
