1/12/2026	08:23	Property Damage Crash	A deputy was dispatched to a business in the 23000 block of State Route 4 to investigate a property damage crash involving a 2016 Volvo semi tractor and trailer that struck a 2010 Honda Insight that was parked in the parking lot. No report was taken.
