5/19/2022	09:54	Arrest Warrant	A Union County Deputy met with a Marion County Deputy to take custody of Tonya M. Boltz, age 45 of Marion for an outstanding arrest warrant. She was transported to the Tri County Regional Jail.
5/19/2022	11:40	Stolen Vehicle	Deputies investigated the theft of a stolen 2008 Triumph motorcycle from a residence on East Center Street in Milford Center. A report was taken, #22-0411.
5/19/2022	12:25	Pursuit	A deputy attempted to stop a 2008 Ford U-Haul Truck that was involved in the theft of a motorcycle in Milford Center on Scottslawn Road near State Route 736. The vehicle failed to stop, and a pursuit ensued. Units from the Marysville Police Department, Plain City Police Department, Dublin Police Department, Hilliard Police Department, and the Ohio State Highway Patrol assisted in the pursuit that traveled onto US Route 33 eastbound and then southbound on Interstate 270.
