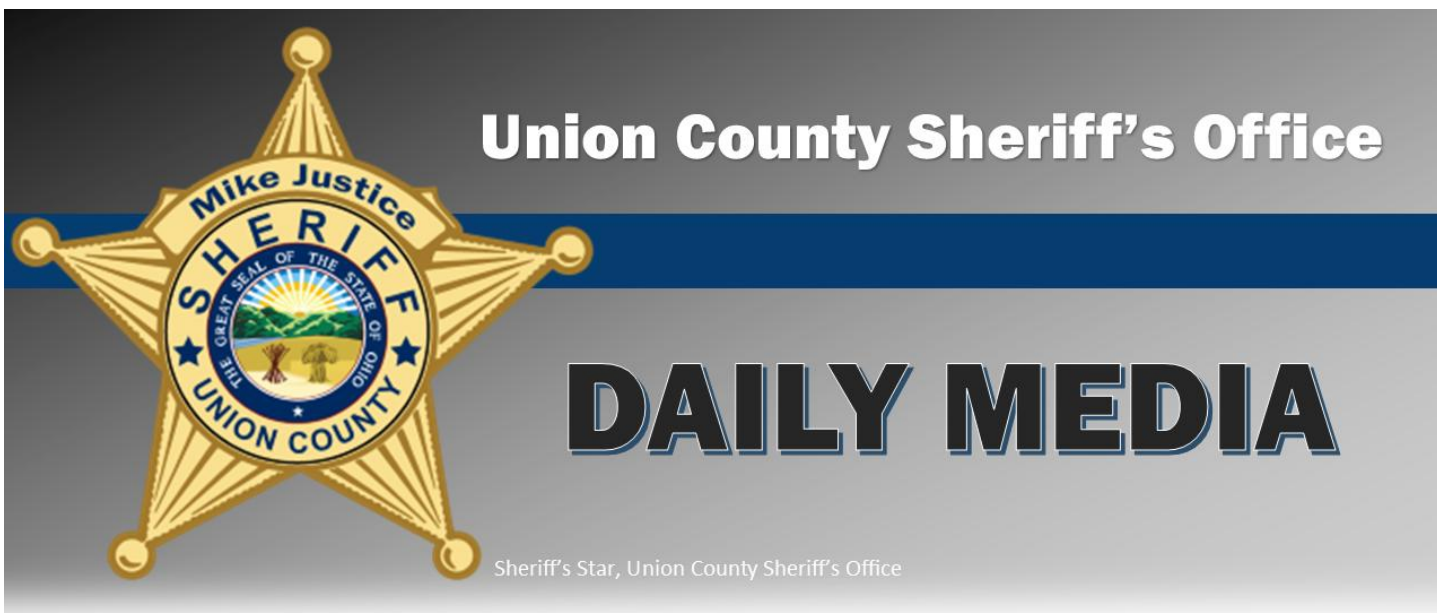

8/11/2026	16:12	Property Damage Crash	A deputy investigated a property damage crash that occurred on State Route 245 near Northwest Parkway involving a 2006 Toyota Scion that was struck from behind by a 2003 Dodge Ram pickup truck that left the scene but was later located. As a result of the investigation, the driver of the Dodge, Nicholas L. Smith, age 19 of Marysville, was issued a traffic citation for failure to maintain an assured and clear distance ahead, and a crash report was taken. #2026-00034030.
8/11/2026	19:05	Impaired Driver	Deputies were dispatched to a driving complaint involving a 2014 Ford F-150 that was reportedly driving erratically on State Route 736 northbound from Taylor Road. Deputies located the vehicle and attempted to catch up to the vehicle to initiate a traffic stop. The driver turned onto Black Cherry Drive and then onto Black Oak Avenue before abandoning the vehicle and fleeing on foot. Units from the Marysville Police Department, Plain City Police Department, and the Ohio State Highway Patrol assisted with setting up a perimeter, and with the aid of a drone, the driver, Zachary C. Gibson, age 38 of Grove City, was located and taken into custody. As a result of the investigation, deputies charged Mr. Gibson with operating a vehicle while impaired, having an open container of alcohol in a vehicle, and obstructing official business, and he was then transported to the Tri County Regional Jail.
