SHERIFF'S OFFICE LIFE SAVING AWARD

Paige DelPico

Dispatcher Paige DelPico was presented with the Sheriff's Office Life Saving Award for her actions in the line of duty on October 30, 2019. During a 911 call received by Dispatcher DelPico, she Dispatched Marysville Fire Department and gave pre-arrival instructions for CPR to the caller. Once it was determine that the victim was in cardiac arrest, Dispatcher DelPico coached the caller through the use of an on-site AED. A shock was given by the AED and Dispatcher DelPico continued to give emergency medical instructions until Marysville Medic 271 arrived on scene. With the collaborative efforts of multiple individuals utilizing the cardiac chain of survival, the victim is still alive today.

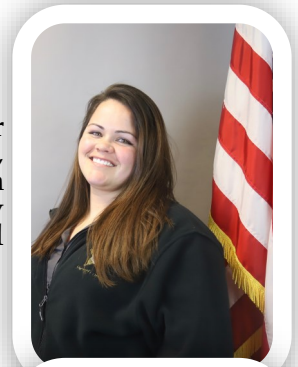

The two suspects were later located, arrested and successfully prosecuted for felonious assault and sentenced to nine years in prison.

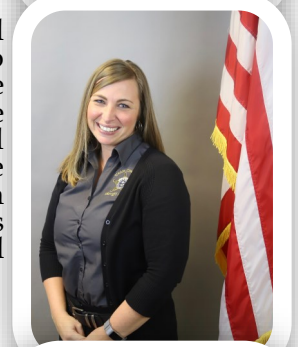
Dispatcher of the Year: Tiffany Cook

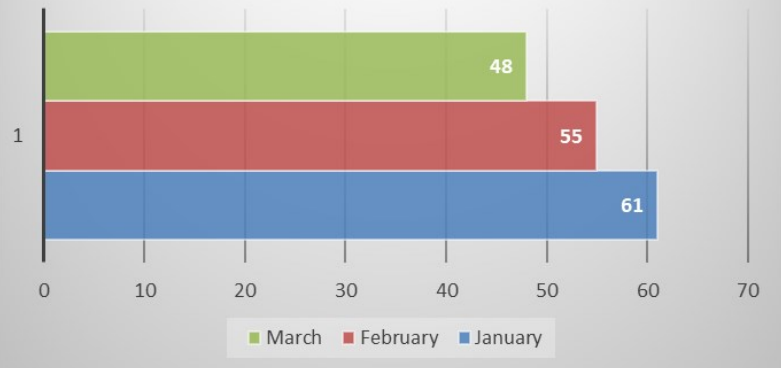

Public Safety Officers

The idea behind the Public Safety Officer (PSO) program was to cross train deputies in the skills needed to also be an emergency medical technician and firefighter. The deputies currently patrol the townships they are assigned with medical gear and firefighting equipment. The equipment includes turnout gear, a full medic bag; and an automatic external defibrillator. This allows the deputy to respond to the scene on any type of emergency and be trained to handle the situation. While the deputy obviously cannot fight a fire alone or transport a patient to the hospital, he can assist the regular medics and firemen. On various occasions these deputies have served as a third person who is needed on a fire truck or emergency squad out of the station.

The PSO also makes a determined effort to get to know the people of their township. This allows residents to feel the deputy is specifically looking out for their safety, which is an aspect of a current trend in law enforcement known as community policing. This means the deputies and the public work as a team to deter crime. Residents also like to see a familiar face patrolling. They take on a sense of ownership of the deputies and that helps break down the walls between citizens and deputies.



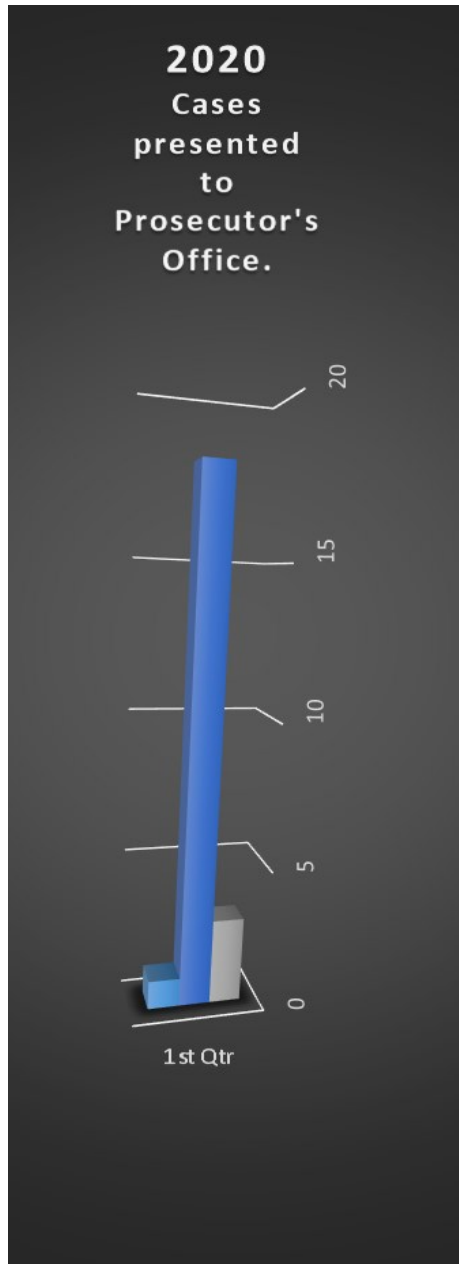

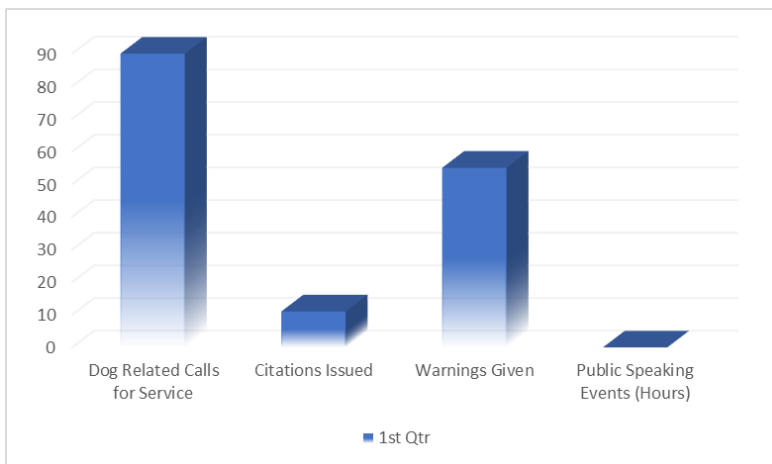

New CIT/CISM Deputy

In January, the Union County Sheriff's Office named Deputy Morgan Brown as the Crisis Intervention Team (CIT) & Critical Incident Stress Management (CISM) Coordinator. This position is grant funded and was created as part of the "Stepping Up Initiative". This initiative is a partnership of the Union County Sheriff's Office, Mental Health and Recovery Board of Union County (MHRBUC), and the Tri-County Regional Jail. The goal of the "Stepping Up Initiative" is to reduce the number of people with mental illnesses in jails.



As the CIT Coordinator, Deputy Brown will be able to provide annual CIT trainings to ensure that all staff has received basic CIT training. Dep. Brown will also be responsible for providing Advanced CIT training, which allows focus on more specialized groups (Autism, Veterans, Youth, etc.). Dep. Brown will be responsible for recording proper data from CIT reports that are completed after every interaction a Deputy has with someone believed to be having a mental health crisis. This data will be shared with the Mental health and Recovery Board of Union County. Having this data will provide UCSO and MHRBUC with guidance for training and equipment to help reduce the number of people with mental illness going to jail.

Dep. Brown will also be working with first responders to help train on how to de-escalate scenarios related to mental illness and transporting individuals to Maryhaven (a behavioral health and addiction center in Union County) as opposed to jail.

The CISM portion of Deputy Brown's position is as a volunteer team member of the public safety and affiliate professionals serving regional fire, EMS, law enforcement, industry, educational, and other organizations involved in any type of critical incident. The CISM team was developed and has evolved into a process that helps people be resistant, to be resilient, and recover from critical incident stress. The CISM team can respond to a wide range of events: Line of duty death; multi-casualty incidents, violence to a child, incidents where responders know the victim, etc. Team members range from Deputy Sheriffs, Marysville Police Officers, Marysville Fire and EMS personnel, MHRBUC personnel, local clergy, and other local support groups. The CISM team can be quickly activated through the local Emergency Management Agency. **To Request CISM Services/Response call: 937-537-0141**


